That this Assembly calls on the Territory Government to define the RR (rural residential) zone as described in the Northern Territory planning scheme, state that the minimum lot size for the RR zone in the Litchfield municipality is 1ha. This was always the definition since that zone was established but only changed last year by the previous CLP Minister for Planning.
