## 3. How many National Parks and Conservation Areas are land trusts under the *Northern Territory Aboriginal Land Rights Act 1976*?

We have 20 parks and reserves managed by the Parks and Wildlife Commission with Aboriginal Land Trust ownership and there are 24 Aboriginal Land Trusts within NT parks and reserves.

4. What are the lease terms and durations for each National Park and when are these leases scheduled to expire? Please provide these details for each Park individually.

Lease terms are as follows -

**LEASES** - Leases are between the Aboriginal Land Trusts (identified in Schedules 1 and 2) of the *Parks and Reserves (Framework for the Futures) Act 2003*, the Northern Territory of Australia and the Northern and Central Land Councils. Each Lease states that the joint management parties agree to establish, manage and maintain a comprehensive and representative system of parks in the NT. The purpose of this system is to benefit Aboriginal people and the wider community and to protect biodiversity. Some standard features are:

- the leases set out a brief history behind the lease agreements;
- identify the parties to the lease;
- identify the land the subject of the lease;
- set out the obligations of the parties and the conditions to which the leases are subject;
- provide mechanisms for such things as the calculation of rent, resolution of disputes and for negotiations for renewal of the leases;
- 99 year lease terms with an option for negotiation for renewal;
- "permitted uses" for the parks are prescribed which are the establishment, joint management, maintenance and use of the park as a park: and
  - to serve visitor and community needs for education and enjoyment;
  - to protect biological diversity;
  - for the appropriate use and enjoyment by relevant Aboriginals according to Aboriginal tradition (including establishing and maintaining living areas, hunting and use of resources in accordance with the Plan of Management); and
  - ancillary and related uses.
- the parks are required to be managed in accordance with principles of joint management which recognise, value and incorporate Aboriginal culture, knowledge and traditional decision making processes.

6. Recently it has been announced that several National Parks located within the Northern Territory, including Litchfield and Nitmiluk National Parks, may be introducing a fee for entry permits. The fee for entry permit scheme would, it was stated, also include an online booking system which could be utilised by international and interstate visitors to manage their trips. Please explain:

## a. What community or industry consultation was undertaken prior to this announcement?

The 2019-20 Budget Strategy and Outlook revenue measures included the introduction of a conservation and park use fee for NT National Parks and access fees for major walking tracks including Larapinta, Jatbula and Tabletop Track.

Consultation with Land Councils (on revenue splits for Joint Managed parks) and Tourism industry groups on implementation matters has commenced.

# b. What evidence exists that the online booking system will be a beneficial addition to the tourism industry of the Northern Territory?

Inter-jurisdictional research and market sounding has found that all jurisdictions have noticed significant benefits from introducing online booking that may flow on to tourism operators including:

- improved satisfaction from park visitors with increased certainty of getting a campsite;
- an improvement in social behavior as people can be traced back to a campsite;
- improved safety outcomes as emergency responders have good information to work with;
- improved compliance with fee requirements resulting in better revenue outcomes and therefore increased capacity to manage assets; and
- improved data on visitor profiles, numbers and satisfaction that will provide information for both the tourism sector and government to refine services and opportunities for activation of the estate.

## c. What are the expected costs of implementing the fee for entry permits system?

It is expected that the costs of implementing an increased and new fees system will be met from within the existing budget.

## d. What are the expected costs of implementing the online booking system?

A future tender opportunity has been released with a tender value of between \$2,500,000 - \$4,999,999. This will include both the initial costs of setting up a system and the ongoing transaction costs over a four year period.

#### e. What is the expected income for the fee for entry permit system?

The expected income from a fee for an entry permit system cannot be established with certainty until consultation with Land Councils has concluded.

### f. What is the expected income from the online booking system?

The 2019-20 Budget Paper Number 3 Revenue Statement in sales of goods and services provided the following for parks camping fees and other associated revenue.

2018-19 Estimate 2019-20 Budget \$1 103 000 \$1 103 000

The online booking system is expected to reduce 'leakage' in the payment of fees that are currently payable for camping in parks and reserves. There is a reported 48% increase in revenue at campsites where volunteer campground hosts are monitoring the requirement to pay for campsites.
