The Department of the Legislative Assembly (DLA) enables the effective and efficient functioning of the Northern Territory Parliament.

We provide operational support and professional advice to the 25 Members of the Legislative Assembly (MLAs), facilitate meetings of the Parliament, produce the parliamentary record, and support its committees to deliver public inquiries. We assist MLAs by providing information, library and research services, administering their entitlements, and supporting electorate offices and electorate staff. We help Territorians wherever they live to access their representatives and their Parliament, and manage and maintain the Parliament building in line with its status as the Territory's seat of government.

We celebrate the Territory's culture and engage deeply with the Territory community We are proud of the Territory's rich Aboriginal culture and traditions and its diverse, multicultural population and seek to assist the Assembly to represent these, both in its procedure and in the precinct. We help enhance engagement across the community by improving the availability of information and encouraging access to the parliamentary precinct and electorate offices. Within our parliamentary education function, we engage with Territorians across remote and regional areas and have accessible online resources for those we cannot reach in person.

We build strong partnerships and invest in our people

We foster a positive and respectful workplace culture and work diligently to build strong relationships across the Parliament, our service partners and the community. With our parliamentary stakeholders, we maintain a customer service mentality that helps Parliament function smoothly and effectively. Strategic Objective 1

Support the functioning and integrity of Parliament

We are the custodians of the Parliament and its principles, procedures and history. We will provide timely and necessary advice and support to guide the legislative process and will promote the integrity and import of the institution of Parliament.

- Provide trusted, reliable and impartial advice to help MLAs fulfil their parliamentary duties.
- Maintain internal expertise and capability to support MLAs to utilise parliamentary processes and committee systems effectively.
- Embrace technological opportunities to improve efficiency and openness, including by implementing a parliamentary information management system to provide centralised and consolidated access to key documents and procedures, both internally and externally.
- Promote the conditions for a culture of collaboration and collegiality within Parliament.



Strategic Objective 2

Deliver highquality services to MLAs and their electorate offices

We will support MLAs and electorate offices to represent their constituents by providing timely and effective administrative and operational services.

- Embed customer-service values across the DLA, including by implementing a customer relationship management system to better track and record our ongoing delivery of services and to inform future improvements.
- Provide enhanced induction, training and ongoing support to MLAs, recognising the unique parliamentary workplace environment and MLAs' differing backgrounds, experiences and ways of working.
- Provide enhanced induction, training and ongoing support to electorate office staff, recognising the diverse needs of the different electorates and electorate offices across the Territory.
- Deepen our engagement with MLAs and their electorate offices to better understand their varied needs and to help them understand our roles and responsibilities.



Strategic Objective 3

Foster engagement between the Assembly and the community

We recognise that the Parliament ultimately belongs to the people of the Northern Territory. We will facilitate the community's engagement with and access to Parliament in line with principles of accessibility, inclusiveness and respect.

- Support the Parliament in celebrating the rich and varied Aboriginal culture of the Northern Territory, and its diverse, multicultural populations.
- Pursue a new parliamentary information management system that supports access and engagement by members of the public and key stakeholders.
- Provide targeted and impactful education outreach, working both independently and alongside partner providers and ensuring effective engagement with remote and regional areas.
- Promote more effective day-to-day use of Parliament House and cultivate its iconic status, including by supporting ease of use for all building occupants, working with expert partner agencies to develop a strategy.
