With a view to avoiding an unwanted gap in the regulatory regime for the Port, the Committee asked the Chair to refer this advice to the Minister and seek his advice on what action he will take to bring the legislative regime for ports within appropriate legislative standards before the committee reports to the Assembly on the regulation.
