- (2) A Member of the Committee who is not a party-aligned Member may nominate in writing to the Chair another Member to stand as proxy for the Committee Member with the consent, in writing, of that Member.
- (3) A Member standing proxy for a Member has the rights of a Committee Member under the Standing Orders.

The Committee agreed to continue the practice of questions first being asked by Shadow Ministers, then Independent Members, then Committee Members, then other participating Members, with Members being given leave to ask intervening questions that follow a line of questioning commenced.
