794 Mr MacFARLANE to MINISTER for LANDS and HOUSING

Has he investigated the means of making more land, presently flood prone, available for housing in Katherine, or is the answer to this problem one for the Minister for Transport and Works as stated in your answer to question No. 534?

ANSWER

Yes. The government has been examining a number of alternative proposals to increase land availability in Katherine and private subdivision near Katherine is expected in the near future.

The government is reviewing policy not to release flood prone land and this may result in further housing blocks becoming available.

861 Mr PERKINS to MINISTER for EDUCATION

- 1. Is the minister aware of a letter, dated 30 July 1979, which was sent to the Director of Education, Dr J. Eedle, by the Acting Director of the Institute for Aboriginal Development concerning the future educational role of the institute?
- 2. Is the minister aware that the Acting Director of the Institute for Aboriginal Development has not received to date a reply from Dr Eedle?
- 3. Can the minister categorically squash the rumour that the Department of Education intends to take over the work of the institute?

ANSWER

- 1. Yes, I am aware of the letter because along with Mr Perkins and 3 others I received a carbon copy of the letter written.
- 2. Yes, I am aware of the delay in both my reply and the secretary's reply and can only apologise for the delay.
- 3. Yes, I can categorically deny this rumour. There has been close cooperation between the department and the institute, as indicated in the letter. The institute is a private agency and obtains its funding from a variety of sources. There is no way that the Department of Education could "take over" institute activities, even if it wished to do so, which it does not, as the department has no influence over its funding arrangements.

ANSWER

- 1. A recreation lake is planned for Alice Springs and 4 sites have been closely considered.
 - Todd River upstream from the Old Telegraph Station;
 - Jay Creek (2 locations); and
 - Birthday Gap on the Hugh River.

No final decision has been made at this time but the Todd River site is preferred for the following reasons:

- proximity to town;
- good access;
- adjacent to existing attraction and reserve; and
- could provide a supplementary water source for Alice Springs in an emergency.
- 2. Discussions on 2 sacred sites in the area of the Todd River site are being held with the Central Land Council.
- 3. The investigations so far have included hydrology, geology and soil conservation. When a firm decision is made on the engineering suitability of the site, environmental considerations will be examined.
- 4. If the tests are satisfactory and a design can be commissioned by the end of this year, work could commence in the second half of 1980.
- 5. It is not possible to give firm costs at this point but an order of cost of approximately \$2 million is envisaged.
- 6. There has been no decision that the recreation lake project will not proceed.

ANSWERS TO QUESTIONS

7. A report on the engineering geology of the Todd River site is being prepared and other reports will follow on completion of investigations. Normal environmental requirements will be satisfied in due course. A formal reply has not yet been received from the Central Land Council.

864 Mr PERKINS to MINISTER for EDUCATION

I refer to Circular No. 79/145, with reference No. 78/2021, which was sent to all Territory schools over the signature of the Deputy Secretary of the Programs Division, dated 3 August 1979 and headed "Northern Territory Department of Education", which instructed school principals to advise their part-time instructors of the uncertainty of their positions, and ask -

- 1. Is this the circular which the minister described as "unofficial" or the result of a "misunderstanding" between Darwin and other Territory centres when he announced publicly that funds for part-time instructors would not be cut?
- 2. Could the minister explain his definition of an "unofficial" circular from officers of his department?
- 3. Will he state what is the precise situation regarding the future of part-time instructors in schools throughout the Territory?

ANSWER

Circular No. 79/145, with reference No. 78/2021, was sent to all Territory schools explaining that a reassessment of part-time instructors allocations would be carried out at the end of August. This is a normal exercise, carried out each year when funds available for part-time instructors are known.

As there are never unlimited funds available for the employment of parttime instructors, each school is advised of its basic allocation for a financial year, and principals are expected to ensure that part-time instructors services are distributed reasonably evenly throughout the year. My department is aware of at least one urban school in Alice Springs where, if the current rate of expenditure continues, the school will have used it 1979-80 entitlement by the end of the 1979 school year. It was felt that the circular was quite clear in its intentions.

- The "unofficial circular" was not a circular as such but a letter written to various part-time instructors in Alice Springs and was promulgated by a departmental officer in that area. It would seem that the person concerned misinterpreted the departmental Circular No. 79/145.
- 2. "Unofficial" was the term applied to the issue of the above-mentioned letter, without clearance by a senior officer who would have picked up the misinterpretation of facts.
- 3. I can assure you that my department has no intention of reducing the services provided by part-time instructors. It is, however, reviewing its administrative procedures in this area with a view to making the most effective use of part-time instructor resources.

866 Ms D'ROZARIO to MINISTER for LANDS and HOUSING

936 Mr MacFARLANE to CHIEF MINISTER

Will sulphuric acid be available to turn phosphate dust and phosphate rock into cheap fertilizer?

ANSWER

The following information has been supplied by the Minister for Industrial Development:

"The question appears to be linked to a recent media announcement about the arrival of a consignment of sulphuric acid in Darwin. This importation was made by Queensland Mines through a facility constructed on land leased from the Port Authority and is for the exclusive use of the company in its processing or uranium ore.".

938 Mr MacFARLANE to MINISTER for HEALTH

What is being done to replace existing medical services aircraft with aircraft capable of being operated economically from airstrips in the Territory by pilots other than commercial airline pilots?

ANSWERS TO QUESTIONS

ANSWER

We are looking at the possibility of replacing Nomad aircraft by a smaller number of faster pressurised aircraft which will enable a more economical use of our total resources. The question of pilots has, however, not been looked at.

942 Mr MacFARLANE to CHIEF MINISTER

Will the Katherine Corporation be allowed to make by-laws <u>ultra vires</u> as a measure to speed up effective local government?

ANSWER

No.

943 Mr MacFARLANE to MINISTER for HEALTH

Will private telephones be available in Katherine Hospital for patients requiring them, such as a businessman confined to hospital with a broken leg?

ANSWER

I have asked the Department of Health to examine the practicality of the rental of private telephones by hospital patients, but provision has already been made for patients' telephones at Casuarina Hospital.

946 Mr MacFARLANE to MINISTER for TRANSPORT and WORKS

What is the estimated completion date for the new water supply for Katherine from the Donkey Camp intake?

ANSWER

July 1981.

- 955 Mr PERKINS to CHIEF MINISTER
 - 1. Who is responsible for the metal sheds being constructed at the Aboriginal camp at Uluru?
 - 2. How many sheds will be built?
 - 3. How much are the sheds costing?
 - 4. How many Aboriginal people live at Uluru?
 - 5. What facilities are to be provided in the sheds?
 - 6. What advice was sought from the Aboriginal community and from experts on Aboriginal housing before work on the sheds was started?
 - 7. Does the minister consider that the sheds are appropriate housing for the Aboriginal people at Uluru?
 - 8. What plans for Aboriginal housing are contained within the proposed Yulara Village?

ANSWERS TO QUESTIONS

ANSWER

1. Aboriginal housing at Uluru (Ayers Rock-Mount Olga) National Park is the responsibility of the Australian National Parks and Wildlife Service. This government, through the Territory Parks and Wildlife Commission, has continued to express its concern at the appalling housing conditions for Aboriginal people camping at Ayers Rock and its disappointment that after nearly 2 years, as far as we have been advised, the ANPWS still only propose to build one house at the park. The Aboriginal people living at the park have traditional affiliations with the area and are, for the most part, elderly people.

In view of this, when the Territory Parks and Wildlife Commission was recently requested by Aboriginal people at Ayers Rock to provide prefabricated all weather shelter similar to that being erected at the Hermannsburg outstation, the TPWC purchased these units and assisted the Aboriginals to erect them at their current camping area at Ayers Rock.

- 2. The TPWC have purchased 2 units and have requested the Central Land Council to advise as to whether it is their understanding that the Aboriginal people want further units and whether the supply of these has the support of Central Land Council. If the answer to both is in the affirmative, the TPWC intend to provide between 5 to 6 additional units. These may not all be of the Hermannsburg type and current proposals are also taking into consideration a housing system designed by the Commonwealth Department of Construction which embody the same principles.
- 3. The 2 units already purchased have cost \$2,331.80 each, delivered on site. It is again stressed that the responsibility for Aboriginal housing on this park rests with the Australian National Parks and Wildlife Service and that the Territory Parks and Wildlife Commission has taken this action to provide some protection for these elderly Aboriginal people.
- 4. To our knowledge, at Friday 28 September, there were 20 Aboriginal people camping at Ayers Rock. This number varies considerably as they are traditionally oriented people and numbers fluctuate considerably with people coming and going on "business" and visiting relatives.
- 5. No facilities are provided in the sheds. They are a simple lock-up weatherproof shed, with windows and an external verandah for outdoor living. They are designed solely for all weather protection and have a heavy duty fibro floor to allow cooking fires to be lit inside if required. If the ANPWS is unable to provide basic services such as water and toilet facilities to the remaining Aboriginal people camping at Ayers Rock, over and above the one house that they propose to build, then the TPWC will probably have to assist once more.
- 6. The sheds were provided in response to the request from Aboriginal people at Ayers Rock. They are designed and built by Aboriginal people at Hermannsburg to suit their housing requirements at the outstations and can be readily transported and re-erected in keeping with their desire to follow a traditional lifestyle. The Commonwealth Department of Construction proposals which are also being evaluated, embody these principles of mobility and in addition, incorporate insulated building materials and a greater flexibility in that they can be added to and expanded to incorporate normal facilities in response to the occupants' needs.

- 7. No one considers the sheds to be appropriate housing for the Aboriginal people at Uluru. They are regarded only as temporary weatherproof shelter, although they may also serve some transitional function in a progression to more sophisticated accommodation. Moreover, it is not intended to impose western values on a people who may prefer a more traditional lifestyle.
- 8. The development plan for the Yulara Village provides for serviced land for the eventual construction of motels, campgrounds and housing lots which will be made available for lease by interested departments, organisations and individuals. Provision has also been made for possible development requirements of Aboriginal groups should they desire areas separate from the planned village development. Actual development of facilities for Aboriginal people will be incorporated in the next stage of development of the Yulara Village, tentatively programmed for 1980-81 and further discussions will be held with the Aboriginal groups on their requirements as a prelude to planning.

(This information was also provided in response to a question from Mr Perkins - 11 September 1979 - on the provision of suitable housing for Aboriginal people in the Yulara Village area).

1037 Mr VALE to MINISTER for TRANSPORT and WORKS

Is it true that confiscated fishing gear has been given by the Fisheries Division and the Department of Industrial Development to Aboriginal communities?

ANSWER

No items of confiscated gear or equipment have been donated to Aboriginal communities for commercial fishing ventures. In some instances, confiscated gill nets have been used in training courses for Aboriginals but, in all of these cases, the gill nets were not marked or tended when seized for being illegally set. No subsequent claims of ownership for any of these nets were lodged with the Fisheries Division. All fishing nets that are in a good condition at the completion of Aboriginal training courses are returned to Darwin. Nets which are damaged beyond economical repair are not returned. It is not current division policy to sell gear back to the offenders. Under government disposal procedure, such gear must be either auctioned or sold by tender. At the moment, we are not disposing of such gear because our powers to do so are imprecise. However, the new Fisheries Bill which was introduced in the last sittings will clear up this problem.

1038 Mr PERKINS to MINISTER for EDUCATION

Is he aware of the activities of the Yipirinya School at Alice Springs? If so, what help does the Education Department propose to give to the school? Is it a fact that the Education Department has actually prohibited the mention of this school on the Aboriginal program on radio 8HA? If so, I would like to know why?

ANSWER

The question has about 4 barrells to it and deals with quite a complex matter. I ask the honourable member to put it on notice.

1039 Mr HARRIS to MINISTER for MINES and ENERGY

I asked the minister some time ago whether the Northern Territory Electricity Commission would be requested to carry out urgent maintenance on overhead wires. Recently, there was another accident in Kahlin. Has he asked for the maintenance to be carried out and, if so, is he able to report on NTEC's progress in that maintenance program?

ANSWER

I recall that the honourable member raised the particular issue of high voltage maintenance in the Darwin area. At the time, I gave an indication to the honourable member of the works that were being done. I took the issue up with the Northern Territory Electricity Commission which advised me that they will be proceedings to have all the rehabilitation and maintenance work in the Darwin area brought to a conclusion as soon as possible. Maintenance is not something that will commence this year and finish next year; it will continue for ever and ever. I guess that the people living in the suburbs of Darwin who are suffering from intermittent blackouts as a result of maintenance operations are well aware that maintenance is a continuing operation. I have not been able to get details of the accident at Kahlin. I am not aware of whether the accident was caused by poor maintenance on the part of the commission but I will endeavour to get and provide that information for the honourable member as soon as possible.

1040 Mrs LAWRIE to MINISTER for EDUCATION

During the August sittings and on 12 September, I asked the Minister when the members of the Education Advisory Council would be appointed. On 12 September he replied that the Executive Council papers were being prepared at the time and that, hopefully at the next Executive Council meeting, his Honour and the Executive Council would consider the matter.

In view of the previous answer to this same question, has executive council met and considered this matter? Can he indicate when these advisory councils will be appointed?

ANSWER

The appropriate documentation is now prepared and, although I gave an undertaking to the honourable member that I would endeavour to get it before his Honour at the next meeting of the Executive Council, difficulty has arisen as to the membership of 1 member. It is for that reason that a re-think had to take place. Nevertheless, the documents are finalised and his Honour the Administrator and the Executive Council should be considering them at the next meeting.

1041 Mrs PADGHAM-PURICH to MINISTER for TRANSPORT and WORKS

Which private people went on the recent trade mission and what was the government's responsibility for their inclusion?

ANSWER

The private people who went on the recent mission to Singapore were Mr Peter Rau from Tristar, Mr Ron Hersey who is a farmer from Katherine, Mr Roger Rooney of V.B. Perkins and Company, Mr John Hickman, Mr Nick Paspalis and Mr Graham Varden. The government had no responsibility for the welfare of these people or to provide fares or financial assistance. However, they are entitled to some reimbursement from the Crown as a result of their expedition to Singapore. Our assistance came in the form of assisting them with appointments with senior officials and generally offering advice wherever possible.

1042 Mrs O'NEIL to MINISTER for HEALTH

Is the minister aware that some part-time nursing sisters at Darwin Hospital have been told, upon taking holidays, that they will be unable to obtain part-time employment on their return? Will the minister investigate this in view of his earlier assurance to the Assembly that part-time employment would continue to be made avialable for these sisters?

ANSWER

I will most certainly investigate the matter. If the honourable member would like to quietly give me the names of the people that are involved, it would make that process of investigation much simpler.

1043 Mr VALE to CHIEF MINISTER

Can he advise what steps he has taken to ensure that Northern Territory residents will receive a direct TV coverage of this year's Melbourne Cup?

ANSWER

Recent reports indicated that the Northern Territory would not receive a direct television coverage of the Melbourne Cup because the Victoria Racing Club had sold exclusive television rights to the 0-10 network which does not service the Northern Territory. In any event, the only commercial television channel in the Territory is in Darwin. Coupled with the problems of television coverage of the cricket and the fact that the Territory missed out on a direct telecast of the VFL grand final, this prompted me to send a letter and a telex to the Chairman of the Victorian Racing Club asking him whether it would be possible, in view of the fact that the 0-10 network did not operate in the Territory, for the VRC to allow the ABC to televise the Melbourne Cup in the Territory. Т must thank the Chairman of the Victoria Racing Club for the promptness of his action. Within 2 days he had indicated that the 0-10 network and the Victoria Racing Club had absolutely no objections, that facilities would be made available to the ABC and that it was up to them from there on in.

At the same time, I sent a telex to the Chairman of the Australian Broadcasting Commission asking him whether he would be agreeable to the ABC in the Territory televising the cup. I have not as yet heard anything from him. In the meantime, I have communicated with him again and told him that the VRC is agreeable. At the present time, it is in the hands of the Australian Broadcasting Commission. I really hope that they won't sulk about televising the Melbourne Cup in the Territory the way they seem to be sulking over providing cricket coverage simply because a commercial interest has the rights elsewhere. The Australian Broadcasting Commission has a very serious responsibility to Territorians because it is the only media network that covers the whole of the Territory and we depend on it to a much greater extent than people elsewhere. I believe that its senior management and the commission itself must have regard to the special requirements of the Northern Territory and be prepared to do things here that they may not necessarily have to do in the states which are well provided with commercial TV coverage.

1044 Mrs LAWRIE to CHIEF MINISTER

In the light of previous answers he has given to my queries regarding Connair and continuing press speculation as to its future, can he give the House any indication of the likely ownership of Connair in the future?

ANSWER

I cannot indicate the expected future ownership of Connair. Most of the press speculation in relation to the future of Connair is generated by the management of Connair itself. Naturally, it wants to try to create as big a market as possible for the sale of the company and I suppose commercially one cannot blame it for that. At present, the Northern Territory government has indicated to any corporation or group that has approached it that the purchase of Connair will not necessarily mean that that person or corporation will be given any rights in the Northern Territory other than those presently held by Connair itself. In other words, a ticket buying Connair will not be a ticket to become the Northern Territory's regional airline. At present, we are in receipt of submissions of one sort or another from East-West Airlines, Trans Australia Airlines and Ansett Airlines. We are waiting for detailed submissions from the 2 major domestic operators and I think, in fairness, that East-West Airlines should be permitted to re-submit if it so desires.

The Northern Territory government is not particularly interested in what they have done in the past but what they are likely to do in the future. We are interested to know things such as anticipated levels of fare, expected frequencies, types of aircraft and the proposed methods by which the airlines would suggest that fares and reight rates be increased rather than the glamorous side of the airline industry. I understand from Mr Connellan that other comapnies may be interested. We have had a telex from him recently indicating that an overseas company is prepared to buy Connair subject to his earlier sale of Connair to TAA or any other company. We will certainly look at all these propositions in some detail but it may be a month before they are received in Darwin.

In the meantime, Connair is quite capable of operating and will continue to receive the federal government subsidy until September of next year. There is no reason for haste; it is not a matter which we should rush into. I have given the staff of Connair - and I think some staff members generate the interests of the honourable member for Nightcliff in this matter - assurances that their interests will be protected. I believe that everyone who has indicated an interest in Connair to date has also indicated that there would be no staff retrenchments. Т really cannot do more than that. I think the government is doing more for Connair staff in that way than the management of Connair has done for its staff over the last several years. Every time it looked like having a subsidy fight with the government, it told the staff that they would all be retrenched or words to that effect and has used them as political muscle in its bid for subsidy. I again report that the government will do everything humanly possible to protect the interests of Connair staff and that everyone in the aviation industry understands this. I do not think I can serve any good purpose by repeated that assurance any more.

Mr BALLANTYNE to CHIEF MINISTER

Because of the

Because of the killing of a Victorian man by a crocodile at the Rainbow Cliff area off Gove last weekend, what steps have been taken by the Territory Parks and Wildlife Commission to have the crocodiles in that area of the Gove Peninsula taken away from those recreational areas?

ANSWER

I was saddened to hear of the tragic and bizarre circumstances of the death of the young skindiver at Rainbow Cliff near Nhulunbuy last weekend. I immeidately asked the Territory Parks and Wildlife Commission to carry out a survey of the number of crocodiles in the area. I believe that the Parks and Wildlife Commission has already established a task force to carry out this job. Attempts will be made to trap and move to another location any crocodiles which are located close to popular swimming or diving areas. Obviously, this will be a difficult taks.

ANSWER TO QUESTION

1046 Mr EVERINGHAM: I have a telex from the Chairman of the ABC which is relevant to an earlier question: "Reference your telex message sent 4 October. Having regard to current commission policy, I cannot give you an assurance that the ABC will carry a live telecast to Northern Territory of Melbourne Cup if VRC agrees to your requests". He had not received my second telex by then. "Film of the race is expected to be included in early evening ABC television news bulletins of Tuesday November 6 in all states and in Northern Territory". It looks as though I will have to go back to the crease.

1047 Ms D'ROZARIO to MINISTER for LANDS and HOUSING

Is the minister aware that a company called Diorama Pty Ltd is building a diorama of Aboriginal folklore and a souvenir shop on lot 4571 in the town of Alice Springs? Can he confirm whether planning approval was given for this development?

ANSWER

I do not know the dates and times of the approvals for a diorama which is being built in Alice Springs. I have no personal knowledge on the subject. However, I will seek the information and pass it on to the honourable member.

1048 Mr VALE to CHIEF MINISTER

Is it proposed to amend the breathalyser legislation to remove the power of police to require all vehicle passengers in road accidents to submit to blood tests?

ANSWER

I have noted newspaper reports of alleged proposed amendments to the breathalyser legislation in the last couple of days. Although there was a file on my desk when I returned to the Northern Territory yesterday afternoon containing certain suggestions regarding a number of aspects of the legislation, that file certainly did not emanate from the police. As yet, no submission in respect of amendments to the breathalyser legislation has gone to Cabinet where it would certainly have to be considered before amendments were agreed to.

The honourable member for Stuart asked whether an amendment is proposed to remove the provision whereby occupants rather than passengers - and I make that distinction deliberately - can be requested to submit to a blood test following a motor accident. It is a matter for a court to determine who was the driver of a motor vehicle that was involved in an accident as a result of which prosecution or civil proceedings might flow; it is not a decision to be taken by the police or by a doctor. How is a doctor to decide who is the driver when persons are brought to him at the hospital? Although I certainly would not expect that the procedure would be a general one, it is for this reason that the provision is in the bill. This provision is contained in legislation in South Australia, Victoria and New South Wales and, legally, I can see a very good reason for it. I am not sure who is proposing any amendments to the legislation at this stage. We will certainly look at any proposal for amendments but I want to bring it to the attention of members so that they will be aware of the specific reason for the inclusion of that clause in the bill.

QUESTIONS WITHOUT NOTICE - Thursday 11 October 1979

1049 Mr DOOLAN to MINISTER for MINES and ENERGY

Has the Dorisvale barytes mine been purchased by Utah company?

ANSWER

I understand that there has been a takeover by Utah of the Australian company that is currently operating in the Dorisvale barytes mine. I am not aware that that transaction has been concluded but I think that, before the Dorisvale barytes mine was included in such a purchase, there should be talks with the Northern Territory government becasue we have invested on roads and improvements in the area to enable that project to get off the ground. If there was some benevolent organisation like Utah around the ridges, we would be willing to talk to thme about the inclusion of the particular mine in such a transaction.

1050 Mr VALE to MINISTER for HEALTH

Can he advise whether the Health Department has done any investigation that will encourage it to proceed with fluoridation of the Katherine water supply?

ANSWER

The short answer is yes. I would just like to bring honourable members up to date with some of the work that has been done by the Health Department in this particular area. As you are aware, Mr Speaker, about 6 months ago there was a lot of opposition voiced in Katherine to bhe proposal that fluoride be introduced to the water there as a means of trying to reduce the prevalence of dental caries in the town. Various groups took exception to the proposal and expressed their opposition. Subsequently, we sent officers from the Health Department to talk to these people and to put the case for fluoride from the health point of view.

After that, I discussed the issue with Dr Gurd and asked him whether the department had made any comparisons between children that were born and bred in Katherine with those that were born and bred in Tennant Creek because Tennant Creek has natural fluoride in its water. It would have been interesting to obtain a comparison of the prevalence of dental caries in children. I thought that such a survey would be a very simple matter and I left it with the department. The department embarked on an exhaustive investigation of the difference between the children in Tennant Creek and Katherine. The survey is common throughout Australia from the point of view of the dental profession. There is a standard system of making comparissons of this nature. It was conducted in both towns by the dentists and the dental therapists. The criteria that we used was based on the Australia-wide criteria. Just to give you a bit of background on that, there is an index which is used by the dental authorities for this evaluation which is called the DMFDEN baseline index. The DMF index indicates the presence of the dental caries. They add these 2 factors and divide the number by the number of people that are involved and come up with what they call a community baseline figure.

The particular survey involved 176 children from Katherine and 96 children from Tennant Creek. The children involved were between 5 and 12 years of

age, born and bred in the towns and had not been out of the area except on holidays or for brief periods.

The results of the survey for the ages of 5-10 years showed that dental caries were 3 times more prevalent among Katherine children than among Tennant Creek children. In the 11-12 year age groups, Tennant Creek children had less dental caries than Katherine children but the department felt that, because there were only 39 children in that classification, they did not really get a good cross-section of the community and a good figure for a baseline index.

Another interesting result came from a comparison of the baseline indices for both Katherine and Tennant Creek with figures from Tamworth and Canberra where fluoride has been added to the water for more than 10 years. The interesting fact was that the existing baseline figure in Katherine, about 5.16, is comparable to the figures available for Tamworth and Canberra before fluoride was added to the water in those 2 towns. The latest figures for Tennant Creek are comparable to the latest figures for Tamworth and Canberra where fluoride has been added to the water for more than 10 years.

The results of the department's investigation show that there is a good deal of benefit to be gained by the addition of fluoride to the water. There will always be objections to fluoride in the water but, from the point of view of preventing dental caries in children, the evidence supports, without any reservation in my mind, the concept of introducing fluoride to the Katherine water supply.

1051 Mr OLIVER to MINISTER for MINES and ENERGY

Can the minister inform me on the development of the Harts Range gem find?

ANSWER

I am not quite sure whether the honourable member is referring to the ruby discovery by Hillrise Investments in that particular area. I advised the House some time ago that a very interesting ruby discovery had been made over a very large strike zone in the particular area. One of the difficulties that confronted the company was marketing the product. The gem must be very pure because there is not much of a market for second-rate rubies.

The company has sent people to Germany and have established that they have a market for their particular product. Recently, they floated an Australian company through the Stock Exchange to further investigate and develop the area.

This discovery lies near the Harts Range, 130 miles out of Alice Springs. I would just like to assure the honourable member that the fossickings of individuals in this particular area will not be interupted by the activities of the company because they are in 2 different locations.
