## Casuarina Bus Exchange

1. I am aware that the Department of Transport provides reports for incidents and tasks undertaken by the Transit Safety Unit. Can you provide a copy of those reports for 2013, 2014, 2015 and to date. If this report is not available will you provide information relating to statistics for incidents and tasks undertaken by transit safety officers in the same years? Please break it down by place of occurrence ie Casuarina Bus Interchange where possible.

Listed below are three tables. The first table is the historical data records for the Transit Safety Unit (TSU) from 2013-14, which prior to the 2014-15 Financial Year, only recorded the total number of serious incidents responded to, and the total number of bus driver requests for assistance. The second two tables are full data reports for the 2014–15 and 2015–May 2016 Financial Years.

As a result of increased staffing levels and the introduction of security guards at interchanges in 2014, statistical increases are likely to have occurred, as all incidents are now being captured and recorded.
