6. Currently, how many FTE staff are designated to the co-ordination and management of kinship carers? What are their positions? And where are they based?

#### **ANSWER:**

The Department of Territory Families, Housing and Communities (the Department) is focussing on building capability in the community-controlled sector to deliver services to both foster and kinship carers. The Department funds seven Aboriginal Community Controlled Organisations for family finding, kinship care assessment, and support services across the Territory to the value of \$1.2 million a year. These services are Julalikari Council Aboriginal Corporation in Tennant Creek, Kalano Community Association in Katherine, Larrakia Nation Aboriginal Corporation and Northern Territory Stolen Generation's in Darwin, Ngaanyatjarra, Pitjantjatjara and Yankunytjatjara Women's Council and Tangentyere Council in Alice Springs and Yalu Aboriginal Corporation in Galiwin'ku. Each provider manages their workload differently depending on their organisational arrangements and funding allocation. All regions partner with their funded locally Aboriginal Community Controlled services partners listed above, and utilise their case management staff to conduct additional assessments and support as required.

Within the Department there are five positions that have specific responsibility to assess and support foster and kinship carers for the Northern Territory. These are located in the Top End and Arnhem regions.

The Greater Darwin, Katherine, Barkly and Central Australia Regions operate generic business models where all professional staff assess prospective carers and provide them with support. This model optimises flexibility to deliver place based services.

The Department also fund the Foster and Kinship Care Association of the Northern Territory to deliver support services to foster carers and kinship carers. The association will receive \$1,053,512 in 2022-23.
