- 5. A quorum of the Committee shall be three members of the Committee.
- 6. The committee is to report in the October sittings.
- 7. The provisions of this resolution, insofar as they are inconsistent with the Standing Orders, have effect notwithstanding anything contained in the Standing Orders.

- Failing to undertake community consultation or preparing a social and environmental impact analysis on the proposed Nightcliff island before issuing a lease and allowing geotechnical drilling to take place; and
- We call on the Minister to stop moves to develop a residential island in our pristine harbour and accept out community values that Darwin is a city built around a uniquely beautiful harbour.
