- 1. How many Supreme Court judges are there permanently appointed?
- 2. When was the last appointment of a permanent Supreme Court judge?
- 3. How many Supreme Court judges are on temporary contracts and, if any, what is the term of the contract for each temporary appointment?
- 4. How many Local Court judges are there on permanent contracts?
- 5. When was the last appointment of a permanent Local Court judge?
- 6. How many Local Court judges are on temporary contracts and, if any, what is the term of contract for each temporary judge?
- 7. If there are temporary Local Court judges, why are they not placed on a permanent employment basis?
- 8. What is the cost difference between a permanent Local Court judge and a temporary Local Court judge salary package and on costs and support staff?
- 9. How many staff are in the Coroner's office?
- 10. How many cases did the Coroner finalise in 2020, 2021 and 2022 to date?
- 11. What is the average wait time for a case to be submitted into the Coroner's office?
- 12. How many days did the Coroner sit for 2020, 2021 and 2022 to date?
- 13. In 2018, how many criminal listings were there in the Supreme Court and how many were there for the 2021 year for Darwin and Alice Springs respectively?
- 14. What is the average time for a criminal matter to proceed through the Supreme Court for the 2020, 2021 and 2022 to date?
- 15. What was the number of criminal sittings days in the Supreme Court for 2020, 2021 and 2022 to date?

ANSWERS

- There are six Supreme Court judges appointed under section 32(1) and one Associate Judge appointed under section 41A of the Supreme Court Act 1979.
- 2. The last appointment of a permanent Supreme Court judge was Justice Sonia Brownhill, who was appointed on 2 November 2020.
- 3. There are no Supreme Court Judges on temporary contracts. Judges are appointed by determination by the Administrator.
- 4. There are 15 Local Court Judges, which includes the president of the Northern Territory Civil and Administrative Tribunal. There are no Local Court Judges on contract.
- 5. The last appointment of a Local Court Judge (who is not an acting Judge) was Judge Thomasin Opie on 18 October 2021.
- 6. There are no Local Court Judges on temporary contracts.
- 7. As the number of Judges appointed under section 50(1)(b) and (c) is capped by section 85(b) the *Local Court Act 2015*.
- 8. The cost difference between a permanent Local Court Judge and an acting Local Court Judge is approximately \$30 000 per Judge per annum.

10. Cases finalised by the Coroner in 2020, 2021 and 2022 (calendar years) to date (as at 25 July 2022 date):

2020: 255 cases;

• 2021: 258 cases; and

2022: 56 finalised cases to date.

11. The average wait time for a case to be submitted into the Coroner's office:

2020 average: 135.9 days;

2021 average: 89.3 days; and

• 2022 average: 29.8 days (to date).

12. The number of days the Coroner sat for 2020, 2021 and 2022 to date (as at 25 July 2022):

2020: 18 inquest sitting days;

2021: 13 inquest sitting days; and

2022: nine inquest sitting days.

- 17. For the period 2020 to 25 July 2022, the average time from the date a matter is opened in the Local Court to the end of the committal process is 170 days.
- 18. For the period 2020 to 25 July 2022, the shortest time is two days.
- 19. For the period 2020 to 25 July 2022, the longest time for a case to proceed to the Supreme Court from the time a person was charged with a criminal offence is 783 days.
