Debate resumed.

Mr Elferink (Attorney-General and Minister for Justice), pursuant to notice, presented a Bill for an Act to amend the Sentencing Act and to make consequential amendments to another Act.

Bill read a first time.

Mr Elferink moved — That the Bill be now read a second time.

Debate ensued.

Paper Tabled: Mr Elferink laid upon the Table the Explanatory Statement (Paper 232).

On the motion of Ms Walker debate was adjourned.

12. SENTENCING AMENDMENT (MANDATORY MINIMUM SENTENCES) BILL 2012 (SERIAL 12):

After clause 8, proposed Schedule 2

insert (in numerical order)

section 155A Assault, obstruction etc of persons providing rescue, medical treatment or other aid if the offender assaulted the other person.

Section 156 Murder.

Clause 8, as amended, agreed to.

Remainder of the Bill, by leave, taken as a whole and agreed to.

Bill to be reported with amendments.

The Assembly resumed; the Speaker took the Chair; the Deputy Speaker and Chair of Committees (Mr Higgins) reported that the Committee had agreed to the Bill with

amendments.

On the motion of Mr Elferink (Attorney-General), the Bill was read a third time and passed to be a proposed law.

13. BAIL AMENDMENT BILL 2012 (SERIAL 13) and DOMESTIC AND FAMILY VIOLENCE AMENDMENT BILL 2012 (SERIAL 14):

Leave granted for a motion for the third reading of the Bill to be moved forthwith.
