6. CENSURE OF CHIEF MINISTER — MOTION

Ms Fyles (Member for Nightcliff) moved — That the Assembly censure the Chief Minister and CLP for:

- gifting the CLP Candidate for Lingiari Tina MacFarlane water rights worth millions;
- stripping Indigenous Territorians of their water rights to hand them instead to their candidate;
- threatening the supply of water to the Ngukurr Community;
- saying that Cabinet and Minister's had no involvement in the decision but then refusing to release correspondence between the CLP and the Water Controller;
- basing their decision to change the science on a phone call;
- ignoring science and modelling that expose the risk of environmental and ecological damage to Elsey National Park and its water systems;
- ignoring the rights of other water users of the Tindal Limestone Aquifer including recreational fishers, traditional owners and other pastoralists;
- giving the Federal Coalition Candidate water rights against the policy of the Federal Coalition; and
- refusing to revoke the water allocation grant until a proper and transparent process can be put in place that involves detailed community consultation.
