### QUESTION:

What grants have been provided under action plan 2.

To which organisations, for what projects?

What was the total value of grants?

Are there any documents of the funded outcomes?

### ANSWER:

The Domestic, Family and Sexual Violence Action Plan 2 (AP2) contains 65 actions across the 4 domains of primary prevention; early intervention and accountability; response and recovery; and systemic enablers and reform. These actions are being implemented by the Northern Territory Government, with a number involving grant funding initiatives to the Domestic, Family and Sexual Violence (DFSV) sector. Funding for these initiatives is sourced from both the Northern Territory and Commonwealth Governments.

The funding allocation for each of the AP2 65 actions is contained within the [Detailed Deliverables under Action Plan 2](#) (2023). This also demonstrates that 27 of the actions included in AP2 are continuing actions from Action Plan 1 (AP1), enabling ongoing continuity of investment in DFSV initiatives.

The table below details specific dedicated grant allocations under AP2 actions committed in the 2023-24 Budget through Northern Territory Government funding (in addition to other funding sources for DFSV initiatives).

The outcomes across these programs under AP1 and AP2 are being compiled in reports across all actions. The first bi-annual report will be published online after July 2024. Reported outcomes align with the theory of change, program logic, evaluation plans, reporting and accountability mechanisms for the DFSV Framework outlined in the [Monitoring, Evaluation and Accountability Plan](#) for DFSV.
