NT Aboriginal Tourism Committee

Terms of Reference (revised Oct 2021)

Background

In April 2015, the Government approved the formation of the NT Aboriginal Tourism Advisory Council (ATAC) to "... contribute to developing sustainable and prosperous Aboriginal tourism enterprises across the Northern Territory, enabling individuals to create or take up meaningful employment and business opportunities and, at the same time, maintain and share their cultural heritage." (ATAC Terms of Reference) It did this by providing "... strategic advice to the Minister for Tourism, Sport and Culture and the Tourism NT Board on issues including, but not limited to:

- *identifying new Aboriginal tourism product and regions that will cater for demand identified through market–led research;*
- identifying Aboriginal tourism enterprise development opportunities including ways by which to build business capacity as well as mechanisms by which to increase the employment of Aboriginal people within the tourism industry;
- *identifying opportunities for access to Aboriginal land and communities where there is a willingness by custodians to be involved in the tourism industry and which is supported by research; and*
- provide advice on strategic marketing initiatives involving Aboriginal tourism." (ATAC Terms of Reference)

Based on the work of ATAC and through the Territory Economic Reconstruction Report (TERC), the NT Government identified the need to develop an NT Aboriginal Tourism Strategic Plan. The Northern Territory Aboriginal Tourism Strategy 2020 – 2030 was released in November 2019.

One of the key initiatives in the NT Aboriginal Tourism Strategy is to "develop an Aboriginal Tourism Committee structure reporting to the Tourism NT Board with functionality transferring to an Aboriginal Tourism Association to be established within the life of the plan".

Purpose

The purpose of the Aboriginal Tourism Committee (ATC) is to guide implementation of the NT Aboriginal Tourism Strategy to achieve its vision for the NT becoming "the undeniable leader in provision of Aboriginal tourism experiences in Australia".

The ATC will contribute to developing sustainable and prosperous Aboriginal tourism enterprises across the Northern Territory, enabling individuals to create or take up

meaningful employment and business opportunities and, at the same time, maintain and share their cultural heritage.

The ATC will undertake to ensure that the work of the Committee is well known and understood through all levels of Government.

Key Principles

The Aboriginal Tourism Committee will operate under the following principles:

- acknowledgement and respect for the principles of the Larrakia Declaration 2012;
- will work to ensure culturally appropriate Aboriginal tourism experiences in the NT are fostered through the sharing and celebrating of Aboriginal culture;
- will continue to mentor, guide, support and evaluate the development of the Aboriginal tourism sector in alignment with the NT Aboriginal Tourism Strategy and in a manner endorsed by Aboriginal people and respectful to cultural identity;
- recognise the key role both Aboriginal owned and operated and non-Aboriginal owned and operated businesses contribute to the development of the Aboriginal tourism sector; and
- commit to supporting the delivery of the NT Aboriginal Tourism Strategy and to partner with Government and industry to enact the key initiatives identified in the plan.

Governance

The Aboriginal Tourism Committee will be appointed by the Minister for Tourism and Hospitality with endorsement from Cabinet.

Membership

- ATC members will be individuals who either have genuine tourism industry knowledge and expertise and/or understanding of or experience in matters crucial to the sustainable development of Aboriginal tourism in the NT. A minimum of six members will be Aboriginal.
- 2. The ATC will comprise a maximum of seven (7) members.
- 3. Members will be selected by the Minister following an Expression of Interest process. The Minister will appoint a Chairperson.
- 4. The ATC Chairperson will be appointed as a Tourism NT Board Commissioner.
- 5. Members of ATC will be paid an appropriate fee and miscellaneous costs commensurate with normal Government practices and reflective of the commitment required to be a member.
- 6. Membership will be for a term not exceeding two years, after which the member may be eligible for reappointment.

- 7. New members will be appointed by the Minister following consultation with the Chief Executive Officer, Department of Industry, Tourism and Trade (DITT).
- 8. The Deputy Chief Executive Officer DITT is an ex officio Committee member and may appoint an appropriate designee to act in this capacity.
- 9. Casual vacancies on the Committee shall be filled at the discretion of the Minister and for a period not exceeding the tenure of the Committee vacancy being filled.

Meetings

- 1. The Aboriginal Tourism Committee will meet at least four times annually with the majority of meetings being held in Alice Springs or Darwin. However, in order for members to gain a comprehensive understanding of regional and remote opportunities and issues, meetings may be held in other locations as required.
- 2. The deliberation of the Committee will be confidential.
- 3. The quorum for Committee meetings will be a majority of the members.

Responsibilities

The Aboriginal Tourism Committee will:

- Assume oversight and delivery of the NT Aboriginal Tourism Strategy through the evaluation and regular reporting to the Tourism NT Board of outcomes and issues affecting the NT Aboriginal Tourism Strategy.
- Represent the NT Aboriginal tourism sector to the Minister and Tourism NT Board.
- Provide regular update reports to the Tourism NT Board on the delivery of the NT Aboriginal Tourism Strategy.
- Provide advice on specific policy and programme effectiveness, to help ensure that Aboriginal tourism programs achieve real, positive change in the lives of Aboriginal people.
- Deliver sound policy and strategic advice to the Minister and Tourism NT Board based upon the delivery of the NT Aboriginal Tourism Strategy.
- Provide strategic advice to the Minister and Tourism NT Board on issues including, but not limited to:
 - identifying new Aboriginal tourism product and regions that will cater for demand identified through market led research;
 - identifying Aboriginal tourism enterprise development opportunities including ways to build business capacity as well as mechanisms to increase the employment of Aboriginal people within the tourism industry;
 - identifying opportunities for access to Aboriginal land and communities where there is a willingness by custodians to be involved in the tourism industry which is supported by research; and
 - providing advice on strategic marketing initiatives involving Aboriginal tourism.
- Inform and communicate with Government agencies the roles and aspirations of the ATC and the NT Aboriginal Tourism Strategy.

The Department of Industry, Tourism and Trade will:

- Provide secretariat support for the ATC.
- Provide budget support as agreed and negotiated with the Department.
- Investigate the creation of Aboriginal Tourism Development Officer roles within Tourism NT during the life of the NT Aboriginal Tourism Strategy.
- Provide opportunities for Committee members to attend appropriate Territory, national and international forums appropriate to the development of the NT Aboriginal tourism sector and in alignment with the NT Aboriginal Tourism Strategy.
- Ensure a position is allocated on the Tourism NT Board for the Chair of the Aboriginal Tourism Committee.
- Support the establishment of an Aboriginal Tourism Association within the life of the NT Aboriginal Tourism Strategy.
- Provide appropriate and timely information to the ATC so the Committee can make informed decisions.

Reporting

The Aboriginal Tourism Committee will submit reports on the Committee's activities and outcomes for all Tourism NT Board meetings, including updates on strategic pillar initiatives in the NT Aboriginal Tourism Strategy.

The Aboriginal Tourism Committee will provide an annual report to the Minister for Tourism and Hospitality on progress of the NT Aboriginal Tourism Strategy.





Northern Territory Aboriginal Tourism Committee Terms of Reference

Background

Based on the work of the Aboriginal Tourism Advisory Council (ATAC) which was formed in April 2015 and through the Northern Territory (NT) Economic Development Framework, the NT Government identified the need to develop an NT Aboriginal tourism strategic plan. The NT Aboriginal Tourism Strategy 2020 – 2030 (Aboriginal Tourism Strategy) was released in November 2019.

One of the key initiatives in the Aboriginal Tourism Strategy is to "*develop an Aboriginal Tourism Committee structure reporting to the Tourism NT Board with functionality transferring to an Aboriginal Tourism Association to be established within the life of the plan*".

Purpose

The purpose of the Aboriginal Tourism Committee (ATC) is to guide implementation of the Aboriginal Tourism Strategy to achieve its vision for the NT becoming "the undeniable leader in provision of Aboriginal tourism experiences in Australia".

Governance

The ATC will be appointed by the Minister for Tourism and Hospitality with endorsement from Cabinet.

Membership

- ATC members will be individuals who either have genuine tourism industry knowledge and expertise and/or understanding of or experience in matters crucial to the sustainable development of Aboriginal tourism in the NT. A minimum of 6 members will be Aboriginal.
- The ATC will comprise a maximum of 7 members.
- Members will be selected by the Minister following an expression of interest process. The Minister will appoint a Chair.
- The ATC Chair will be appointed as a Tourism NT Board Commissioner.
- Members of ATC will be paid an appropriate fee and miscellaneous costs commensurate with normal NT Government practices and reflective of the commitment required to be a member.
- Membership will be for a term not exceeding 2 years, after which the member may be eligible for reappointment.
- New members will be appointed by the Minister following consultation with the Tourism NT Board Chair and Chief Executive Officer, Department of Industry, Tourism and Trade.
- The Chief Executive Officer of the Department of Industry, Tourism and Trade is an ex officio Committee member and may appoint an appropriate designee to act in this capacity.
- Casual vacancies on the ATC shall be filled at the discretion of the Minister and for a period not exceeding the tenure of the ATC vacancy being filled.

Meetings

- The ATC will meet at least four times annually with the majority of meetings being held in Alice Springs or Darwin with the final approach being informed by available budget. However, in order for members to gain a comprehensive understanding of regional and remote opportunities, meetings may be held in other locations as required.
- The deliberation of the ATC will be confidential.
- The quorum for ATC meetings will be a majority of the members.

Responsibilities

The ATC will:

- Assume oversight and delivery of the Aboriginal Tourism Strategy through the evaluation and regular reporting to the Tourism NT Board of outcomes and issues affecting the Aboriginal Tourism Strategy.
- Represent the NT Aboriginal tourism sector to the Tourism NT Board and when requested the Minister.
- Provide regular update reports to the Minister via the Tourism NT Board on the delivery of the Aboriginal Tourism Strategy.
- Provide advice on specific policy and program effectiveness, to help ensure that Aboriginal tourism programs achieve real, positive change in the lives of Aboriginal people.
- Deliver sound policy and strategic advice to the Tourism NT Board, and when requested the Minister based upon the delivery of Aboriginal Tourism Strategy.

- Provide strategic advice to the Minister and Tourism NT Board on issues including, but not limited to:
 - identifying new Aboriginal tourism product and regions that will cater for demand identified through market led research;
 - identifying Aboriginal tourism enterprise development opportunities including ways to build business capacity as well as mechanisms to increase the employment of Aboriginal people within the tourism industry; o identifying opportunities for access to Aboriginal land and communities where there is a willingness by custodians to be involved in the tourism industry which is supported by research; and
 - providing advice on strategic marketing initiatives involving Aboriginal tourism.
- Inform and communicate with government agencies the roles and aspirations of the ATC and the Aboriginal Tourism Strategy.

The Department of Industry, Tourism and Trade will:

- Provide secretariat support for the ATC.
- Provide budget support as agreed and negotiated with the Department.
- Create Aboriginal Tourism Development Officer roles within Tourism NT for the duration of the Aboriginal Tourism Strategy.
- Provide opportunities for ATC members to attend appropriate NT, national and international forums appropriate to the development of the NT Aboriginal tourism sector and in alignment with the Aboriginal Tourism Strategy.
- Ensure a position is allocated on the Tourism NT Board for the ATC Chair.
- Support the establishment of an Aboriginal Tourism Association within the life of the Aboriginal Tourism Strategy.
- Provide appropriate and timely information to the ATC so the ATC can make informed decisions.

Reporting

The ATC will submit reports on the ATC's activities and outcomes for all Tourism NT Board meetings, including updates on strategic pillar initiatives in the Aboriginal Tourism Strategy.

The ATC will provide an annual report to the Tourism NT Board which will ultimately be provided to the Minister for Tourism and Hospitality, on progress of the Aboriginal Tourism Strategy.
