- a) a select committee on the Electoral Amendment Bill 2016 comprising two government members and one opposition member to be nominated in writing to the Speaker by the relevant Whip and Mr Wood be appointed,
- b) the chair of the committee must be a government member,
- the Electoral Bill 2016 (Serial 155) be referred to the committee to consider whether the bill should be passed or amended, and the committee is to report to the Assembly by 20 April 2016,
- d) the resumption of the second reading debate for the Electoral Amendment Bill be an Order of the Day for the day following the tabling of the committee's report or the date the report is due, whichever occurs first,
- e) I be allowed again to speak to the question that the Electoral Amendment Bill be read for a second time for up to 10 minutes when the debate on the question resumes,
- f) this resolution has effect not withstanding anything in the standing orders.
