Dear Mr Ferrall

State submissions to the Inquiry into Horizontal Fiscal Equalisation

Thank you for your letter regarding the Commission's call for submissions to its Inquiry into Horizontal Fiscal Equalisation, in which you request an extension of the deadline for State and Territory submissions.

Your letter is timely, reaching us on the first day of our initial consultation with State and Territory governments last week. This allowed us to discuss the best way forward in a practical sense with the first two jurisdictions. And what I propose in this letter addressed (for them) the timing concerns you raise.

As you note, the Commission is working to a tight timeframe. The Commission is required to prepare a draft report, hold public hearings and deliver a final report by 31 January 2018. Recognising these timeframes, and the relatively well-informed stakeholder group for this Inquiry, the Commission eschewed our tradition of preparing an Issues Paper as a precursor to calling for submissions. Instead on 19 May 2017, soon after receipt of the terms of reference, the Commission issued a request for initial submissions with a guidance note. This was with a view to providing interested parties (and especially State and Territory governments) with six weeks to prepare submissions.

We understand that preparing submissions in this time frame may be challenging, but our reporting imperatives see us needing submissions by 30 June 2017.

The Commission is especially mindful of the time required for most State and Territory jurisdictions to secure Cabinet approval of submissions. The Commission has previously been flexible in how we receive input from States and Territories, including agreeing to receive draft, in-confidence submissions (pre Cabinet clearance). And we would be happy to do the same in this Inquiry and for the circumstances that you raise. This has worked well for the Commission and State and Territory

jurisdictions on past inquiries, most recently from my own experience on the Natural Disaster Funding Inquiry.

This would allow the Commission to maintain work momentum by way of our early incorporation of that material into our analysis and early drafting. Formal submissions, once cleared by your respective Cabinets, can arrive by your proposed date of 1 August 2017. Only the latter approved submissions would be made available on our website and ultimately cited in our draft report.

We look forward to working with you on this Inquiry.
