# **NT Police Mandatory Retirement Age**

The Northern Territory Police Force are the only Northern Territory Public Sector Employees that are forced to retire after they reach the age of 65. The mandatory age of retirement for Northern Territory Police was raised in 2007, from 60 to 65 years of age.

## Question:

1. Why are Northern Territory Police Force subjected to mandatory retirement?

#### **Answer:**

The age of retirement is legislatively mandated in the *Police Administration Act 1978 (PAA)*, specifically section 22 as follows:

- (1) A member who has attained the age of 55 years may retire from the Police Force; and
- (2) A member who attains the age of 65 years ceases to be a member of the Police Force.

What is the process by which Northern Territory Police are dismissed from their employment at the age of 65 years of age? Is the dismissal immediate at their 65th birthday? Can they extend beyond their birthday?
