

3. The integration of Health and Welfare Centres commenced on 1 February 1993.

These Community Care Centres will be located at Palmerston, Casuarina and Darwin. A Child and Family Protective Services Unit will also be set up to deal with notification of suspected child abuse and will be located at 60 Cavenagh Street Darwin.

- Ø To date, Integrated Community Care Centres' concept, goals and objectives have been developed and the type and method of service delivery has been finalised. Performance Indicators have been developed to provide continuous evaluation of the effectiveness of integrated service delivery.
- The major focus of the Centre will revolve around a 'client-centred' service delivery using Primary Health Care and Community Development concepts.
- Ø The Centre Managers have been appointed.
- Ø An extensive training program for staff has been developed and commenced, using existing resources.
- Modifications of the Darwin and Casuarina facilities are nearing completion. There have been some delays in the extension of the Palmerston Community Care Centre but it is to be operational by June 1993.
- 4. The Palmerston Community Care Centre commenced on 1 February 1993 although modifications to the facility were not completed.
- 5. There was an initial delay while the outcome of the Cresap review was awaited and then a further delay while decision on accommodation was finalised. Unlike Darwin and Casuarina Integrated Centres where there is existing space that could easily be redesigned to accommodate staff, the Palmerston Integrated Centre requires extension to the existing Community Health Centre.
- 6. All three (3) Community Care Centres as well as the Child and Family Protective Services will commence operations concurrently as planned.
