Mr Yan to the Minister for Health:

#### **Kidney Disease and Dialysis**

### 1. What is the prevalence of kidney disease amongst Territorians? Can you please provide this figure for each of the past 5 years?

Data for each of the past 5 years is not available. The latest published data on prevalence in the Aboriginal Northern Territory population is from 2012-13 at 33% (12,000 people).

Published 2020: Australian Institute of Health and Welfare 2020. Profiles of Aboriginal and Torres Strait Islander people with kidney disease.

NT Health is continuing to analyse data from multiple sources and statistical modelling to estimate NT CKD prevalence and undiagnosed cases in Aboriginal and non-Aboriginal populations. Currently 90% of people accessing dialysis services in the Northern Territory are Aboriginal.

### 2. How many people currently access dialysis services in the NT?

Dialysis can be provided by two methods: haemodialysis (HD) and peritoneal dialysis (PD). Table 1 provides the most recent available data.
