That the Assembly resolves that:

1. There be appointed an Estimates Committee of the Legislative Assembly (the committee) for the purpose of examining and reporting on the:
 - (i) estimates of proposed expenditure contained in the Appropriation (2026–2027) Bill (the Appropriation Bill) and related budget documents
 - (ii) Treasury Legislation Amendment Bill 2026, Serial 64
 - (iii) activities, performance, practices and financial management of the Power and Water Corporation, Jacana Energy and Territory Generation with reference to those corporations' Statements of Corporate Intent of 2026–27.
2. The membership of the committee will be three government members, one opposition member and one crossbench member to be nominated in writing to the Speaker by the relevant Whip or crossbench member. Nominations to the Speaker should occur no later than Monday 11 May 2026.
3. The committee may hold hearings on the following days:
 - Tuesday 9 June 2026
 - Wednesday 10 June 2026
 - Thursday 11 June 2026
 - Monday 15 June 2026
 - Tuesday 16 June 2026
 - Wednesday 17 June 2026
 - Thursday 18 June 2026.
4. The total time for the hearings of the committee may not exceed 60 hours.
5. The maximum time of the appearance of the Chief Minister and the Treasurer shall not exceed eight hours. The maximum time of the appearance of the Auditor-General shall not exceed 30 minutes. For each other minister and the Speaker the maximum time of their appearance shall not exceed seven hours.
6. The committee will publish a schedule of the days and times of hearings and the times allotted for hearings from ministers, the Auditor-General, the Speaker and board Chairs by Friday 15 May 2026. The committee may only amend the published schedule with the consent of the Leader of Government Business.
7. The committee shall examine the proposed expenditure contained in the Appropriation Bill by portfolios in accordance with an agenda published by the committee, and the proposed expenditure shall be considered on an output-by-output basis for each portfolio unit, except that the Auditor-General's Office shall be examined separately from outputs relating to the Chief Minister's portfolio.
8. At the hearing for the Auditor-General's Office:
 - (i) questions relating to the Auditor-General's Office shall be put to the Auditor-General
 - (ii) no agency-related whole-of-government budget and fiscal strategy questions

- shall be asked, except questions strictly relating to the Office's appropriation or administrative arrangements
9. All questions should conform to Standing Order 109, and answers will be concise and directly relevant to the question asked.
 10. Answers to questions taken on notice during the hearings, or additional information about an answer given by or on behalf of a minister, the Auditor-General, the Speaker or board Chair, are to be written and given to the Estimates Committee Secretariat by Monday 13 July 2026. Answers or additional information so received are authorised for publication.
 11. The Clerk of the Legislative Assembly is authorised to publish a transcript of the committee proceedings, whether or not it has been edited, as soon as practicable.
 12. Evidence taken in public by the committee and documents presented to the committee are deemed to be authorised for publication by the committee unless the committee orders otherwise.
 13. At a hearing of the committee the Chair may, after a warning, order any Member of the Assembly whose conduct, in the opinion of the Chair, continues to be disorderly or disruptive, to immediately withdraw from the committee for a period of one hour.
 14. Following their second reading the Bills stand referred to the committee for report by 18 June 2026, after which consideration in detail will take place followed by the third reading.
 15. The Assembly's routine of business for Thursday 18 June 2026 is:
 - (i) 2.30 pm—prayers and acknowledgement of country
 - (ii) report from Estimates Committee and consideration of the Appropriation (2026–2027) Bill 2026 and the Treasury Legislation Amendment Bill 2026.

That the Assembly condemns the Finocchiaro CLP Government for delivering a Budget that completely fails Territorians, delivering no real cost of living relief, no pipeline of infrastructure works, no plan to support the growth and prosperity of critical job-creating sectors, and no economic vision for the future of the Northern Territory.

4. Biodiversity Laws

That the Northern Territory Legislative Assembly:

1. Recognise the Northern Territory's unique biodiversity—its ecosystems, wildlife and cultural landscapes—and the vital role it plays in our lifestyle heritage, economy and resilience.
2. Notes with concern rising threats to biodiversity, including habitat loss, invasive species, climate change and unsustainable land use.
3. Highlights the current lack of comprehensive biodiversity legislation, leaving protection and management of our natural assets inadequate.
4. Commends local communities, Traditional Owners, and environmental organisations for their advocacy and stewardship.
5. Calls on the CLP Government to:
 - Develop and introduce robust biodiversity laws that:

- Protect native species and threatened habitats.
 - Prevent and control invasive species.
 - Promote sustainable land and water use alongside economic development.
 - Embed Aboriginal cultural landscapes and traditional knowledge in management.
 - Consult transparently with Traditional Owners, land councils, scientists, conservation groups, pastoralists and industry.
 - Allocate sufficient funding and resources for implementation, monitoring and enforcement.
 - Set clear, measurable targets aligned with national and international conservation goals.
6. Urges the Government to show leadership in safeguarding our natural heritage so future Territorians can continue to enjoy the landscapes that define our region.

5. Youth Hub

Notice given by: Mr Brown

Status: To be moved:

That the Northern Territory Legislative Assembly:

- Recognise the importance of providing a highly accessible safe place for young people to connect with each other, engage in fun activities and access the support they need; and
- Condemn the Finocchiaro CLP Government for relocating the Youth Hub without proper consultation and without adequately considering the needs of young people of the Northern Suburbs.

6. Affordable Housing

Notice given by: Mr Paech

Status: To be moved:

That the Northern Territory Legislative Assembly:

1. Note that secure, affordable housing is essential for the wellbeing of all Territorians;
2. Recognise the Northern Territory faces a housing crisis, with shortages in urban areas and severe overcrowding in remote communities;
3. Express concern about the Government's cuts of over \$100 million from housing, including urban, remote, government employee housing, and housing in homelands and town camps;
4. Calls on the Government to urgently restore and increase investment in housing infrastructure, ensuring funding for new builds, upgrades, and maintenance;
5. Calls on the Government to deliver on Commonwealth housing programs in full, including the Housing Australia Future Fund and National Housing Accord;
6. Urges the Government to fulfil its commitments to provide safe, sustainable, and culturally appropriate housing across the Territory.

7. Wellbeing of Future Generations

Notice given by: J Davis

Date: 27 March 2025

Status: To be moved:

That this Assembly:

1. Acknowledge that young people today are the first generation in modern history to be worse off than their parents. We are leaving our children a far harder world to flourish in than the one we inherited. We need to have long term solutions that we know will protect our children's future.
2. Takes action to create long-lasting protections for the next generations of Northern Territorians by establishing a select committee to investigate and report on the creation of a Wellbeing of Future Generations Bill, that:
 - 2.1. Requires that intergenerational equity and wellbeing be considered and promoted in all government and public decision-making.
 - 2.2. Imposes a responsibility on government and public bodies to consider the long-term impact of their decisions.
 - 2.3. Requires a Statement of Compatibility with the provisions and objects of the Bill to be completed for Bills which are put before the Parliament.
 - 2.4. Establishes an independent officer, or appoints an existing public officer, to oversee compliance and conduct investigations regarding the Bill to ensure that its object are achieved.
 - 2.5. Conducts a comprehensive community consultation across the Territory to gather input for the creation of the Bill.
3. That the committee be composed of two members from the government, two from the opposition, and two from the crossbench to be nominated in writing to the Speaker by the relevant Whip or crossbench member, with the chair being a non-government member.
4. That the committee be able to report to the Assembly periodically, but must deliver its final report with recommendations within 12 months of this resolution.

8. Healthcare Providers

Status: To be moved:

That the Northern Territory Legislative Assembly:

1. Recognise the importance of individual choice in accessing public and private healthcare services across the Northern Territory, and the critical role choice plays in ensuring timely, quality, and accessible care for Territorians.
2. Recognise that preserving and expanding choice between public and private providers allows Territories to make decisions that best suit their medical needs, financial circumstances, and personal preferences.
3. Urge the Finocchiaro CLP Government to:
 - Work with healthcare stakeholders and the Federal Government to maintain and encourage access to private healthcare options across the Northern Territory; and

- Support the growth and sustainability of private healthcare providers in the Territory.

9. Renewable Energy

Status: To be moved:

That the Northern Territory Legislative Assembly:

1. Urgently invest in renewable energy infrastructure and technology to support the Territory sustainable energy future.
2. Recommit to the 50 per cent renewable target by 2030, in recognition of the importance of progressing our renewable energy capabilities.
3. Continue to commit to the Remote Power System Strategy so that 70 per cent of the combined electricity consumed in 72 remote Territory Communities serviced by Indigenous Essential Services (IES) comes from renewable energy by 2030.

10. Public Sector Integrity

Notice given by: J Davis

Date: 14 May 2025

Status: To be moved:

That this Assembly:

1. Affirms the critical importance of integrity, transparency, and accountability in the Northern Territory public sector and all levels of government;
2. Acknowledges growing public concern about misconduct, conflicts of interest, and corruption in parts of the NT public sector, whether actual or perceived, and the need to restore trust in government institutions;
3. Notes the current limitations in investigative and enforcement powers available to integrity bodies in the Northern Territory, including but not limited to the Office of the Independent Commissioner Against Corruption (ICAC), particularly in relation to whistleblower protection, transparency of outcomes, and responsiveness and action on complaints;
4. Calls on the Northern Territory Government to:
 - a) Strengthen ICAC's independence, powers, and resources to ensure thorough and timely investigations;
 - b) Create a cross-party Parliamentary Integrity and Oversight Committee to monitor and report on ethical conduct and integrity issues across government;
 - c) Implement a public register of interests for senior public servants, statutory officeholders, and ministerial staff, which will be updated regularly and subject to independent audit;
 - d) Introduce a mandatory Code of Conduct for public sector agencies, with clear standards, reporting obligations, and consequences for breaches;
 - e) Strengthen whistleblower protections, including anonymous reporting, legal safeguards, and accessible complaint pathways;
 - f) Commission an independent review of integrity frameworks across the Territory, including complaints handling, conflict-of-interest management, and procurement practices;

- g) Revise the lobbyist regime to require a public, real-time Register of Lobbyists, including details on lobbyists, Ministers or Members involved, and the matters under consideration, as well as the publication of Ministerial diaries.
5. Commits this Assembly to leading by example by adopting stronger internal accountability measures, improving committee transparency, and ensuring the community has confidence in the integrity of its elected representatives and democratic institutions.

11. Clean Air Act

Status: To be moved:

That this Assembly:

- Recognises the serious health and economic impacts of air pollution in the Northern Territory,
- Notes that Darwin now has the worst air quality in Australia, costing over \$100 million annually.
- Calls on the NT Government to develop and implement a Clean Air Act within two years, with enforceable standards, real-time monitoring, and community involvement.

12. NT Aboriginal Interpreter Service

Status: To be moved:

The NT Legislative Assembly:

- Acknowledge the important and extensive work of the Northern Territory Aboriginal Interpreter Service in its 25 year legacy.
- Recognise the Northern Territory is one of the most linguistically diverse areas in the world, and the expansive and challenging requirements of the role of interpreters in NT contexts.
- Recognise the right for Territorians to access public services in a language they understand, and the value of embedding interpreter services across all relevant sectors of the public service.
- Urge the Government to increase their commitment to funding the Aboriginal Interpreter Service, acknowledging the importance of strategic, long-term and intersectoral investment to ensure the service is able to sustainably recruit and develop the Aboriginal interpreter workforce to deliver its core business operations across urban, regional and remote locations of the NT.

13. Alcohol Action Plan for the Northern Territory

Notice given by: J Davis

Date: 12 February 2025 (amended 18 March 2026)

Status: To be moved:

That this Assembly:

1. Acknowledges the alcohol policy initiatives of the current government;

2. Recognises that the drivers of alcohol harm are longstanding and complex, and that the development and implementation of these alcohol policy initiatives must therefore:
 - Be undertaken in genuine partnership with community representatives and sector experts;
 - Include comprehensive strategies for prevention, harm reduction, early intervention, and treatment support;
3. Recognises this Assembly's commitment to shared decision making and therefore commits to ensuring that Aboriginal communities are properly informed and meaningfully engaged in the development of tailored solutions that reflect their specific needs, strengths and concerns;
4. Acknowledges the role of alcohol in exacerbating domestic, family and sexual violence, and prioritises the safety of women and children;
5. Acknowledges that effective alcohol policy must be made in the interests of public health and wellbeing above commercial interests; and
6. Commits to establishing measurable outcomes, long term policy planning and transparent reporting that extend beyond electoral cycles.

14. Crime Soaring in Alice Springs

Status: To be moved:

That the Assembly condemns the Finocchiaro CLP Government for failing to address the crime crisis in Alice Springs.

15. Population Growth in the Northern Territory

That the Assembly:

- Acknowledges the importance of population growth to the Northern Territory's future economic future; and
- Urges the CLP Government to outline its clear plans to grow the Territory population, beyond platitudes and hollow commitments.

16. Secondary Supply of Alcohol

Status: To be moved:

That the Assembly:

- Recognise the severe negative impacts of secondary supply of alcohol and illicit substances on communities, residents, homes and businesses; and
- Call on the CLP Government to address the links between health, crime, violence and child protection issues associated with substance abuse.

17. Nighttime Economy Strategy

Status: To be moved:

That the Assembly call on the CLP Government to develop and implement a Territory night-time economy strategy which supports and enhances visitor experiences, events and activities and after-hours businesses.

18. Strengthening Mental Health Services for All Territorians

Notice given by: J Davis
Date: 27 November 2025
Status: To be moved:

That this Assembly:

1. Notes that while the NT has the Mental Health Strategic Plan 2019–2025 and the 2024–29 Mental Health and Wellbeing Plan, many Territorians, especially in remote, regional and Indigenous communities, still face major gaps in access to culturally safe and timely mental-health support.
2. Acknowledges calls from mental-health advocates for long-term funding, better access to psychosocial support, earlier intervention, and stronger cultural and community-led models of care.
3. Calls on the Government to:
 - fully fund the current plan Territory-wide Mental Health Strategy with a focus on prevention, early intervention and remote accessibility;
 - Expand culturally safe, community-led mental-health services.
4. Commits to targeted consultation and engagement with the Mental Health sector and Lived Experience sectors to ensure the effective implementation of the plan, as per the commitment made at the Health and Mental Health Minister's meeting in June.
5. Report annually on service access, wait times and outcomes across the Territory.

19. Future of Jabiru and the Gove Peninsula

Status: To be moved:

That this Assembly:

1. Acknowledge the impact of the cessation of mining in both Jabiru and the Gove Peninsula, their local communities, businesses, government services and broader regions.
2. Recognise the need for ongoing Government investment to ensure a strong and sustainable future for both Jabiru and the Gove Peninsula, helping the transition from mining towns to vibrant and sustainable regional services hubs that support thriving communities and diverse economies.

20. Remote Health Access

Status: To be moved:

That this Assembly:

- Acknowledge the importance of improving access to timely, quality and culturally safe patient focused health care across remote areas in the Northern Territory; and
- Condemn the Finocchiaro CLP Government for scrapping the \$20 million dollar health centre and morgue designated for the Gunbalanya community.

21. Public Health Approach to Reducing Crime

Notice given by: J Davis

Date: 14 October 2025

Status: To be moved:

That this Assembly, noting the Government's stated commitment to reducing crime in the Northern Territory, calls on the Government to:

- Recognise that effective and lasting crime reduction requires a public health approach, addressing the root causes of offending, including poverty, housing insecurity, alcohol and drug harm, family violence, and childhood trauma.
- Notes the proven success of this approach in jurisdictions such as Glasgow and Birmingham, where adopting a public health model has led to dramatic and sustained reductions in violent crime.
- Act consistently with the findings of the Royal Commission into the Protection and Detention of Children in the Northern Territory, which recommended a public health and therapeutic approach to youth justice and child protection.
- Commit to developing and resourcing a Territory-wide Public Health Crime Reduction Strategy, in partnership with Aboriginal organisations, community services, health providers, and local government.
- Report back to this Assembly within 12 months on progress towards developing and implementing this strategy.

22. Banned Drinkers Register Review

Notice given by: Mr Young

Date: 27 November 2025

Status: To be moved:

That the Northern Territory Legislative Assembly:

1. Acknowledge:

- a. The Banned Drinkers Register Review undertaken by the CLP Government's Alcohol Policy Taskforce (the Taskforce), comprising NT Health, Licensing NT, the Department of the Attorney-General and Justice, NT Police, and other subject-matter experts

2. Note:

- a. That the Taskforce, as part of the CLP Government initiated review, has recommended:

- The use of enforceable undertakings to require on-premises ID scanning for licensees who repeatedly breach their liquor licence conditions.
 - The development of an opt-in system for clubs that choose to participate in on-premises scanning.
 - The broadening of data-sharing arrangements between key agencies to support collaboration, alongside increased training for authorised increased training for authorised persons to improve referral pathways to the Banned Drinkers Register.
- b. That implementing the CLP Government's own Banned Drinkers Register Review was a key election commitment made during the 2024 campaign.
3. Calls on the Minister for Alcohol Policy to provide the Assembly by no later than Thursday 12 March 2026:
- a. A Ministerial Report outlining progress on the implementation of all recommendations arising from the review; and
 - b. A timeline for the introduction of any legislation required to give effect to the Taskforce recommendations.

23. Appointments of NT Administrators

Status: To be moved:

That this Assembly:

Calls on the Chief Minister, in response to widespread community concern, to request that the Governor-General review the process of the Commissions of the general appointments of Administrators of the Northern Territory.

24. Auditor-General Performance Audit Powers

Notice given by: J Davis

Date: 4 February 2026

Status: To be moved:

That this Assembly:

1. Recognises that the independence and effectiveness of the Auditor-General are fundamental to public accountability, transparency, and trust in government spending.
2. Notes with concern that the Northern Territory Auditor-General is currently ranked last in Australia for independence, lagging behind every other Australian jurisdiction and international neighbours such as Papua New Guinea and Fiji.
3. Acknowledges that unlike other Australian jurisdictions, the Northern Territory Auditor-General lacks the statutory power to conduct performance audits, which are essential for assessing whether government programs are operating effectively, and efficiently.
4. Notes the urgent calls from the Australasian Council of Auditors-General (ACAG) and the NT Auditor-General for a full rewrite of the Audit Act 1995 to modernise the office's mandate and align it with best practice standards.
5. Calls on the Government to:
 - a. Develop and introduce amendments to the Audit Act 1995 to explicitly grant the Auditor-General the power to conduct

performance audits, ensuring the office can examine the efficiency and effectiveness of public expenditure, not just financial compliance;

- b. Ensure these amendments provide the Auditor-General with full discretion to exercise a broad audit mandate without interference from the Executive Government; and
- c. Commit to providing adequate and stable funding to the Auditor-General's office to ensure it has the resources necessary to undertake these expanded performance review functions effectively.

25. Transition to a Wellbeing Economy

Notice given by: J Davis

Date: 4 February 2026

Status: To be moved:

That this Assembly:

1. Recognises that Gross Domestic Product (GDP) is a limited measure that fails to capture inequality, environmental sustainability, or the true health of our communities, and that an economy should be designed to serve people and the planet, rather than the other way around.
2. Notes the success of international jurisdictions, such as New Zealand, Scotland, and Wales, in adopting wellbeing frameworks that prioritise early intervention and intergenerational equity.
3. Calls on the Government to:
 - a. Develop a Territory Wellbeing Framework that moves beyond simple economic metrics to include a dashboard of indicators measuring social, environmental, and human capital;
 - b. Implement a 'Wellbeing Budget' process similar to New Zealand, requiring all budget proposals to be assessed on their long-term impact on human health, social cohesion, and climate resilience;
 - c. Adopt a 'Community Wealth Building' approach to procurement and economic development, ensuring that public spending is retained locally to support Territory jobs and businesses.

26. Investing in Territorians with Disability

Notice given by: J Davis

Date: 4 February 2026

Status: To be moved:

That this Assembly:

1. Recognises the importance of foundational supports for people with disability in the Territory and the urgent need to work to reduce the systemic barriers in place.
2. Notes that a significant portion of people with disability in the Northern Territory are eligible for the National Disability Insurance Scheme (NDIS), but NDIS services are in short supply making many reliant on mainstream and foundational services that are often under-resourced or inaccessible.
3. Acknowledges that Aboriginal people with a disability in the Territory often face "double disadvantage" due to the

intersection of disability and discrimination, and that culturally appropriate services are critical for their wellbeing.

4. Recognises the unique challenges of service delivery in rural and remote areas, where "thin markets" and workforce shortages prevent many Territorians from accessing the daily supports they need.
5. Calls on the Government to:
 - a. Invest in robust foundational supports outside of the NDIS to ensure that the majority of Territorians with disability who are ineligible for the scheme or cannot access services due to shortages can still access essential assistance, transport, and community participation services;
 - b. Commit to increasing the supply of accessible social and affordable housing that meets universal design principles, noting that people with disability are disproportionately affected by the Territory's housing shortage and overcrowding; and
 - c. Support the growth of the Aboriginal community-controlled sector to deliver disability services, ensuring that supports are culturally safe, trauma-informed, and available in remote communities where mainstream NDIS providers are often absent.

27. New Alice Springs Hospital

That the NT Government:

Acknowledges that when considering building the next new hospital in the NT, at the very top of the list is a new Alice Springs Hospital; and, that no other NT town or region needs and deserves a modern, new hospital more than Alice Springs and central Australia.

28. Recommitting to the Aboriginal Justice Agreement

Status: To be moved:

That this Assembly:

1. Acknowledges that the Aboriginal Justice Agreement is a cornerstone framework for improving justice outcomes for Aboriginal Territorians through partnership, shared responsibility and community-led solutions.
2. Acknowledges that the long-term justice reform required: Genuine partnership with Aboriginal people, stable and predictable funding, and a commitment to prevention, diversion and community-based responses; and
3. Calls on the Government to publicly recommit to the Aboriginal Justice Agreement beyond 2027 and a guarantee full funding for the agreement for 4 years.

29. Child Safety Standards

1. Note that the Northern Territory's commitment to implement recommendations from the Royal Commission in institutional responses to child sexual abuse.
2. Recognise the need to legislate and operationalise child safety standards with an effective oversight mechanism to operationalise enforcement.
3. Affirm the need for undertake further work to build awareness and capacity within the community and organisations to comply with standards to ensure organisations engage children to create a child safe culture, adopt strategies and take action to promote child wellbeing and prevent harm.

30. Housing as a Human Right

Recognises housing as a fundamental human right and calls on the Government to fully enact the 'Better Deal for Renters' policy while urgently increasing investment in social and affordable housing and adopting a 'Housing First' approach to ensure secure housing for all Territorians

1. Recognises the warnings from recent research including the Federal Government's National Climate Risk Assessment (NCRA) that parts of the Northern Territory could become "unliveable" within decades due to "lethal heat".

 - a. Commit to emissions reduction targets consistent with keeping global warming to 1.5°C, noting that opening huge new fossil fuel reserves such as the Beetaloo Basin is incompatible with a safe, liveable future for the Northern Territory.

1. Recognises the Aboriginal and Torres Strait Islander Child Placement Principle and affirms its importance in ensuring children are raised safely within family, culture and community wherever possible;
2. Embed the Aboriginal Child Placement Principle to the standard of active efforts in legislation;
3. Calls on the Northern Territory Government to provide adequate, ongoing and sustainable funding to properly support kinship carers and foster carers, recognising the critical role they play in caring for vulnerable children;
4. Calls on the Northern Territory Government to mandate priority access to public housing for kinship carers and for families and individuals fleeing domestic and family violence, to ensure safe, stable and appropriate accommodation;
5. Calls on the Northern Territory Government to ensure that Territory parents/carers have access to fully funded, full-time early childhood education and care services, including permanent childcare centres where communities identify the need.

35. CLP Failure to Act on Cost of Living Relief

1. Notes that Territorians are facing escalating cost-of-living pressures, including record rents, rising power bills, high interest rates and unaffordable airfares, with housing and energy costs consuming an increasing share of household incomes;
2. Acknowledges the CLP Government's failure to deliver promised fuel price reforms, its inaction on airfares, and warnings from local governments that cost-shifting will drive up council rates; and
3. Condemns the CLP Government's failure to provide meaningful cost-of-living relief and calls on it to immediately deliver action on power prices, fuel pricing transparency, airfares and direct support for families, renters, seniors and young Territorians.

36. Children's Mental Health Support

1. Acknowledge the importance of supporting the safe and healthy development of children's mental wellbeing so they have the best opportunities in life.
2. Recognises the role of healthy and respectful relationship education, especially for children who are disengaged from school or who have child protection or youth justice involvement, or who have unmet learning or disability needs.
3. Condemns the CLP Government's failure to address children's poor mental health outcomes, the rates of child self-harm and/or suicide and the barriers to seeking support.

38. Strengthening Parliamentary Scrutiny and Democratic Processes

1. Recognises that, as a unicameral parliament, the Northern Territory Legislative Assembly has a heightened responsibility to ensure transparent, accountable, and well-scrutinised law-making.

3. Notes that in all other unicameral parliaments in Australia, all Bills are routinely referred to a relevant parliamentary

4. Calls for Standing Orders to be amended to align with minimum standard practice in other Australian unicameral parliaments to:
 - a) allow any Member to refer a Bill to the Legislative Scrutiny Committee; and
 - b) require all Bills to be accompanied by explanatory material outlining policy objectives, consultation undertaken, costs, and key economic, social and community impacts
 5. Refers this matter to the Standing Orders Committee to examine options to strengthen legislative scrutiny and report back to the Assembly by 30 August 2026.
