4. CENSURE OF CHIEF MINISTER AND HIS CLP GOVERNMENT – MOTION NOT AGREED TO

Ms Lawrie (Leader of Opposition) moved - That this House censure the Chief Minister and his CLP Government for the lack of any ethical standards of leadership and behaviour including:

- Refusing to conduct a full and independent Judicial Inquiry into the actions of CLP slush fund Foundation 51 since its creation.
- Refusing to instigate an inquiry under the *Inquiries Act* into the granting of Water Licenses since September 2012.
- Failing to ensure that serious allegations of criminal behaviour are immediately passed on to police for investigation.

Mr Elferink (Leader of Government Business) informed the Assembly that the Government would accept the censure motion, pursuant to Standing Order 95.
