#### **Electorate Offices**

Staff separations occurred in the following Electorate Offices during the period 1 January 2010 and 31 March 2011:

Electorate Officers are identified by the initial of their Electorate and then A,B or C. For example there are three officers from Port Darwin referred to as DA, DB and DC.

## **Period of Service**

## **Separation Payments**

Separation payments were made as follows:

## Port Darwin

Electorate Officer DA (Termination)was paid entitlements under the terms of service which provides for two weeks salary for every year of service and payment of any accumulated leave entitlements, a total of \$3305.75.

An additional payment was made under a deed of release on the advice of the Department of Justice, the terms of which are confidential

Electorate Officer DB (Termination) was paid entitlements under the terms of service which provides for two weeks salary for every year of service and payment of any accumulated leave entitlements, total of \$1944.13.

An additional payment was made under a deed of release on the advice of the Department of Justice, the terms of which are confidential

Electorate Officer DC (Resignation) had not served for more than a year and was entitled only to any accumulated leave pay, total \$2598.76. This officer separated from the office on approximately 15 June 2010 and the effective date of resignation was 16 July 2010.

## Nightcliff

Electorate Officer NA (Retirement) was paid entitlements under the terms of service which provides for two weeks salary for every year of service and payment of any accumulated leave entitlements, total \$6605.34.

### Johnston

Electorate Officer JA (Retirement) was paid entitlements under the terms of service which provides for two weeks salary for every year of service and payment of any accumulated leave entitlements. a total of \$25, 587.54.

#### Araluen

Electorate Officer AA (Resignation) was paid entitlements under the terms of service which provides for two weeks salary for every year of service and payment of any accumulated leave entitlements, a total of \$11,627.83.

#### Wanguri

Electorate Officer WA (Resignation) was paid entitlements under the terms of service which provides for two weeks salary for every year of service and payment of any accumulated leave entitlements, a total of \$6929.65.

## Sanderson

Electorate Officer SA (Termination) had not served for more than a year, and no accumulated leave entitlements were paid, total \$2173.83.

An additional payment was made under a deed of release on the advice of the Department of Justice, the terms of which are confidential
