Question 1:

What (if any) Greenhouse Gas emissions target should the Northern Territory adopt?

Greenhouse gas emissions from human activities are the drivers of human-caused climate change. Every jurisdiction emits greenhouse gases generated from activities by people, small business and industry.

In order to tackle the increase in greenhouse gases in the atmosphere, countries have signed up to international agreements committing them to reducing their emissions within given timeframes. This can be expressed as a percentage by a certain year or as a percentage below a previous year's emissions.

The latest international agreement is the Paris Agreement of November 2016. It commits Australia to a target of reducing GHG emissions by 26-28% below 2005 levels by 2030. In order for Australia to meet this target, each state and territory has a role to play. Although the NT's emissions are a lot smaller than states like NSW and WA, it is still important for us to decide what level of emissions reduction (if any) we are willing to sign up for, and if this commitment is best represented by a numerical target.

A number of other Australian states and territories have GHG emissions targets ranging from 20% reduction to net zero emissions.

Without a target, it will be difficult for the NT to evaluate effectiveness of emissions policies.

Different sectors make different contributions to the Territory's total GHG emissions and will contribute different emissions mitigation outcomes. Instead of a Territory-wide target, one option is to develop different targets for different sectors as each sector has a different level of impact.

Question 2: What should businesses and governments be doing to reduce emissions?

In addition to commitments by governments to reduce emissions from their activities, businesses are becoming increasingly involved in climate change issues. Many companies are committing to taking real action to address climate change, making pledges to decrease their GHG emissions, reduce their reliance on carbon-rich fuels and invest in sustainable resource management and renewable technology.

An increasing proportion of the private sector is also calling on governments to take climate change action.

Businesses and governments both have many opportunities to reduce emissions.

Some examples of business initiatives are:

- Supporting local offset programs, particularly carbon offset programs through fire management
- Prioritising the use of local suppliers and enhancing supply chain efficiency to reduce supply chain emissions;
- Utilising energy efficient equipment and processes that both lower emissions and reduce production costs
- Collaborating with researchers to investigate options to lower their carbon emissions through innovative operation methods and models
- Setting their own voluntary energy efficiency, renewable energy or emissions targets
- Setting their own bans on single use plastics.

Some examples of government initiatives are:

- Using energy efficient technologies for buildings and transport
- Using greater amounts of renewable energy as a proportion of total energy use
- Partnering with industry to research innovative solutions to mitigate their emissions
- Engaging with animal and plant production industries to adopt sustainable practices

Question 6: What type of regulations do you think would assist industry in being accountable for their impact on climate change?

Many companies have a principal obligation to prepare a sustainability report through their industry codes. For example, mining companies reports on CO2 emissions from its operations, and are accountable for any excess emissions. This encourages companies to manage their emissions better. Self-regulation is one option that provides flexibility to self-impose targets and reduce climate impact in an affordable, sustainable and manageable way.

Another option is increased government regulation of industry. This can be good when it is in the public interest and would likely require specific requirements or standards to address climate change associated risks or damage. However, the prescriptive nature of some government regulation can limit industry flexibility and is often expensive to administer. As mentioned above, governments can regulate industry through cap and trade systems, while some countries such as Sweden have put taxes on carbon emissions. In Victoria, the government has a range of powers designed to assist meeting the state carbon emission reduction target. For example, the Environment Protection Authority has the power to enforce the replacement of inefficient technology used at sites of emissions intensive activity.

Government can also regulate to reduce emissions from households. This would include initiatives aimed at driving consumer behaviour and could include incentives for being 'green'. The downside of this is that it can be an expensive option for government and hence taxpayers.

Question 7:

Are you prepared to pay higher prices for goods and services as businesses pass on the cost of mitigation? If yes, what actions are you willing to take to mitigate or reduce the impact of climate change?

The following are some options for reducing emissions:

- A public levy on some products: would provide funds that could be used to develop more sustainable technology and/or be used to offset the climate impact of the product you are consuming
- Greening your commute: This can mean you take the bus, ride a bike, car share, walk, offset your emissions when you fly, drive an electric or hybrid vehicle if the option is available
- Make your household single-use plastic free: This can include using glass containers, choosing not to purchase items that use less plastic packaging and investing in a reusable coffee cup (often resulting in a discount for your coffee)
- Using energy wisely can mean you: change to energy-efficient light bulbs, unplug appliances when you're not using them, use cold water in the washing machine, minimise use of a clothes dryer, install a programmable thermostat, look for energy star labels when buying new appliances or get a home or workplace energy audit to identify where you can make energy-saving (and cost saving!) gains
- Changing consumption means you could: eat a meat-free meal at least once a week and buy local produce
- Install solar systems in residential, rental or business properties; or seek advice on clean energy investments in your financial portfolio

Question 8: What support do you need to help you to mitigate or adapt to climate change?

TERMS OF REFERENCE AND ROLE OF FUEL EMERGENCY ADVISORY COMMITTEE

The Department of Primary Industry, Fisheries and Mines plays a key coordinating role in the operation of the Fuel Emergency Advisory Committee (FEAC). FEAC is responsible for developing a coordinated Government response to liquid fuel crises in the Northern Territory and acts as an advisory body to the Minister responsible for the *Essential Goods and Services Act.* Its functions include pre-emergency planning, through devising and updating a Northern Territory Fuel Emergency Plan, and the provision of advice to the Minister as to the exercise of his/her powers under the Act during a declared fuel shortage. FEAC comprises representatives from government agencies and departments, and from the oil industry.

FEAC usually meets once or twice a year to address any impending issues which may impact on the supply of liquid fuel in the Territory and to ensure the Fuel Emergency Plan and the FEAC membership are current.

The Department represents the Northern Territory on the National Oil Supply Emergency Committee, which is responsible for national oil emergency measures and for liaison with the International Energy Agency on matters of oil allocation in an international emergency.

ACTIVATE DARWIN ADVISORY BOARD

BACKGROUND

In January 2019 Activate Darwin commenced operations, providing a strategic and coordinated approach to Darwin City revitalisation, activation and promotion.

Activate Darwin is governed by an Advisory Board comprising representatives from NT Government, City of Darwin, Darwin Waterfront Corporation, Cullen Bay Management Authority, private sector stakeholders and industry associations with members operating in the city centre.

Sub-committees will be established, one focused on activities that occur in the daytime economy and one on the night-time economy. Each sub-committee will provide regular reports to the full Advisory Board meeting.

Standard NT Government Board remuneration conditions will apply for members of the Board.

PURPOSE

The Activate Darwin Advisory Board will comprise representation from key stakeholder groups in the city. It will work collaboratively to provide advice and expertise to the Director, Cities relating to revitalisation, activation and promotion of Darwin city centre.

SCOPE

Darwin city centre area with a primary focus on the CBD from the Darwin Waterfront to Cullen Bay. The Director, Cities provides regular reports to the Advisory Committee on the operations of Activate Darwin and seeks input to, and endorsement of, strategies and significant campaigns.

ROLES AND RESPONSIBILITIES

The Advisory Board is accountable for:

- Providing strategic direction, setting the strategies, goals, action plans, policies and performance targets to meet stakeholder expectations.
- Monitoring performance against strategies and plans, including taking action to leverage opportunities or address weaknesses.
- Maintaining the focus of the Advisory Board on Activate Darwin's scope, outcomes and benefits.
- Ensuring compliance with statutory obligations, legal and accounting requirements and government policy and practices.
- Identifying risks and ensuring suitable processes are in place to manage or mitigate those risks.
- Reporting progress to stakeholders, including the NT Government and members of the community.
- Monitoring and managing the factors outside the Advisory Board's control that are critical to Activate Darwin's success.

Members of the Advisory Board commit to:

- Providing meaningful advice and input as required, including consultation with their industry sector as necessary and appropriate.
- Attending all meetings.
- Advocating for Activate Darwin as a key Darwin City Deal initiative.

RESOLUTIONS AND DECISION MAKING

Matters requiring a decision are determined by consensus of the members present.

HYDRAULIC FRACTURING INQUIRY IMPLEMENTATION ONSHORE SHALE GAS COMMUNITY AND BUSINESS REFERENCE GROUP

TERMS OF REFERENCE

1. Background

On 27 March 2018, the *Scientific Inquiry into Hydraulic Fracturing in the Northern Territory* (the Inquiry) released its Final Report. The Inquiry found that provided the recommendations in the report are adopted and implemented, the environmental, social, cultural and economic risks associated with hydraulic fracturing of shale reservoirs could be minimised to an acceptable level.

On the 17 April 2018, the Northern Territory Government accepted all the recommendations of the Inquiry and lifted the moratorium on unconventional gas in the Northern Territory. The Inquiry recommended a series of actions be completed before exploration approvals are issued, with the remainder implemented before any production begins. Responsibility for implementing the 135 recommendations spans a number of different departments. The Department of the Chief Minister has established an implementation team to coordinate the delivery of the recommendations.

Chapter 16 of the Final Report makes recommendations regarding coordinating implementation. Recommendations 16.2, 16.3 and 16.4 set out the need for an implementation framework, team and reference group respectively.

2. Purpose

The Onshore Shale Gas Community and Business Reference Group (**Reference Group**) provides a forum for Government to seek advice and share information on the development of the implementation plan to deliver on the 135 recommendations and their subsequent execution.

The purpose of the Reference Group is to provide:

- Advice to the Northern Territory Government on the implementation plan and its subsequent execution to ensure that the plan aligns with community and industry expectations;
- a forum to share information and provide opportunities for cooperation, and collaboration with key stakeholders and the community; and
- a medium through which key stakeholders can communicate their views about the implementation framework and its subsequent execution directly to the Government.

3. Composition of the Reference Group

The Chief Executive of the Department of the Chief Minister invited a Chairperson and members to be part of the Reference Group.

The members appointed bring a diversity of skills and stakeholder views from the community, environmental groups, local business, land councils, the gas industry, and local Government.

Non-government appointees are entitled to sitting fees for non-statutory bodies as defined by Class C2 sitting fees.

Members are entitled to be paid a travelling allowance for each overnight stay away from the member's usual place of residence, and reimbursement of reasonable expenses as approved by the Chairperson, upon production of receipts.

4. Code of Conduct

To maximise transparency and enhance value of the Reference Group, members may receive information deemed as confidential or sensitive. Members shall not distribute papers deemed confidential or disclose confidential information, and will be required to sign a disclosure of interests.

Members shall act ethically and be respectful of differing views within the Reference Group. Members shall declare interests which may constitute a conflict, and not seek to obtain a benefit, pecuniary or otherwise, from the information received by being a member of the Reference Group.

5. Terms of Appointment

The Membership of the Reference Group will be for a one year term. Members who do not attend two consecutive meetings may have their membership reviewed by the Chairperson.

6. Role of the Chairperson

The Chairperson will be the only media spokesperson for the Reference Group.

The Chairperson will advise members of their roles and responsibilities as members of the Reference Group.

The Chairperson will conduct meetings to foster effective consideration of issues referred to or raised by the Reference Group.

The Chairperson will settle meeting dates and agendas for meetings.

The Chairperson may nominate an alternate Chair in the event they are not able to attend a meeting.

7. Operating arrangements

Four meetings will be held during the appointment period.

A quorum for a meeting of the Reference Group shall comprise half the membership.

Proxies are not permitted.

The Chairperson may invite a non-member to attend meetings.

8. Reporting arrangements

The Reference Group will develop a public communique in each meeting to be made available on the website within 7 days following the meeting. It is the intent that the Communique will be interpreted into Aboriginal languages, in accordance with availability and advice from the Aboriginal Interpreter Service.

The Reference Group will provide direct feedback and advice to the Hydraulic Fracturing Inquiry Implementation Taskforce in the Department of the Chief Minister.

9. Role of Government Agencies

The Hydraulic Fracturing Inquiry Implementation Taskforce in the Department of the Chief Minister will provide secretariat support to the Reference Group and will help the Chairperson organise meetings, prepare agendas and record of meetings.

Northern Territory Government staff from various agencies will provide relevant technical information to assist the Reference Group to develop its advice and recommendations.

Territory Brand and Population Committee - Terms of Reference

1 Background

1.1. In August 2018, the Chief Minister launched the NT Masterbrand (*Masterbrand*) and the 2018-28 Northern Territory Population Growth Strategy (*Population Strategy*). The Masterbrand and Population Strategy are designed to work together to increase the Territory's population, drive economic growth and create jobs by shifting outside perceptions of the NT and encouraging people to live, work, invest, study and do business here.

2 Purpose

2.1. The Territory Brand and Population Committee (*Committee*) is established to draw together a range of locally-based experts and stakeholders with differing perspectives and experiences to provide consensus, independent advice to the Chief Minister through the Chief Executive of the Department of the Chief Minister (*CE DCM*) on the strategic direction of the Masterbrand and the Population Strategy. This will support the development of effective policy and ensure the Masterbrand and the Population Strategy have maximum impact and produce the best possible outcomes for local business, Government and the community. The Committee will also advocate and support the community to promote and adopt (where appropriate) the Masterbrand and Population Strategy.

3 Role

- 3.1. The role of the Committee is to:
 - (a) monitor the overall progress of the Masterbrand and the Population Strategy by providing strategic oversight, risk management consideration and direction advice;
 - (b) provide advice to Government on the status and effectiveness of actions to establish and develop the Masterbrand and the Population Strategy;
 - (c) work closely with external stakeholders to identify potential Masterbrand and Population Strategy initiatives and develop long term strategies for their success;
 - (d) advise Government agencies, the private sector and community on effective use of the Masterbrand and Population Strategy by:
 - (i) facilitating understanding of the Masterbrand and the Population Strategy;
 - (ii) supporting stakeholders through aiding idea generation to capitalise on the Masterbrand and the Population Strategy;
 - (e) ensure key stakeholders are represented in the Masterbrand's and the Population Strategy's development, management and coordination.
- 3.2. The Chief Minister may refer supplementary tasks at his or her discretion.
- 3.3. The Committee will generally be afforded confidential access to relevant policy and initiative documents in the development stages to enable advice and input. Access to sensitive or commercial-in-confidence information is out of scope for the Committee, including materials relating to Government's deliberative decisions, tenders, contracts and handling of individual matters.
- 3.4. The Committee is an advisory body and does not have any authority to act in place of the DCM NT Masterbrand and Population Strategy Team.
- 3.5. The CE DCM has sole discretion and responsibility to decide any actions relating to the Committee's advice.

4 Membership

- 4.1. The Committee will consist a number of persons, appointed by the Chief Minister.
- 4.2. Of the persons appointed to be members, the Chief Minister must appoint not less than:
 - (a) 7 business and not-for-profit representatives;
 - (b) 4 Northern Territory Government representatives (including 1 ex-officio member);
 - (c) 2 local government representatives; and
 - (d) 2 professional industry body representatives.
- 4.3. The Chief Minister may appoint more persons to the Committee at any time and for any reason.
- 4.4. In appointing persons as members, the Chief Minister must:
 - (a) only appoint persons who, in his or her opinion, possess the appropriate skills, knowledge and credentials;
 - (b) consider selecting person from regional Territory locations; and
 - (c) consider any potential conflicts of interest people may have in the business of the Committee.
- 4.5. The Chief Minister may, in appointing persons, have regard to people with marketing and stakeholder engagement experience.
- 4.6. The Executive Director, Strategic Communications and Engagement, DCM is an ex-officio member of the Committee.
- 4.7. A member holds office for 3 years from the date of appointment. A person may be re-appointed as a member.
- 4.8. A member may resign at any time by way of notice in writing addressed to the Chief Minister (*member* includes the Chairperson).
- 4.9. The Chief Minister may terminate the appointment of a member or remove any member appointed at any time and for any reason.
- 4.10. The Chief Minister will appoint a member to be the Chairperson.
- 4.11. The Committee may appoint a member to be the Deputy Chairperson to act as the Chairperson if the Chairperson is unable, for any reason, to exercise the powers or perform the functions of the position or there is a vacancy in the position.
- 4.12. Members of the DCM NT Masterbrand and Population Strategy Team may attend meetings as observers.
- 4.13. The Committee must make codes of conduct in relation to the activities and conduct of members of the Committee.

5 Term and Review

- 5.1. At the end of each year, the Committee must prepare a report on its activities during that year. The Committee must give the report to the Chief Minister through the CE DCM.
- 5.2. After 2 years, the Committee will be reviewed to assess its performance and ongoing operation.
- 5.3. The Chief Minister may amend the Committee's terms of reference as he or she sees fit.

6 Meetings

- 6.1. The Committee must meet within each quarter in a year (*quarter* means the period of 3 months starting from January, April, July and October).
- 6.2. The CE DCM must attend 1 meeting of the Committee within each year.
- 6.3. The Chairperson may convene any supplementary meetings as are necessary for the Committee to perform its role.

- 6.4. The DCM NT Masterbrand and Population Strategy Team will provide secretariat services to the Committee. This includes organising meetings and preparing meeting agendas (in consultation with the Chairperson), distributing information to members and compiling records (minutes and action items).
- 6.5. Copies of the Committee's meeting outcomes and advice will be provided to the Chief Minister through the CE DCM, with the CE DCM advised of outcomes relevant to government policy or process.
- 6.6. A quorum for a meeting of the Committee is a majority of its members.
- 6.7. Members may not appoint a person to attend the meeting as the member's proxy.
