TERMS AND CONDITIONS OF DEMONSTRATIONS / RALLIES AT PARLIAMENT HOUSE

In the interest of safety your group must adhere to the conditions for demonstration as listed below:

- All activity is at your own risk
- Unruly, violent and/or offensive behaviour will not be tolerated
- Food and beverages are not to be prepared or sold
- Alcohol is not permitted
- Vehicle access points and carriageways must be kept clear for official and/or emergency vehicles
- The Parliament building is not to be tampered with or defaced in any way and the front steps, forecourt and surrounding areas are to be left in a clean state after the event. As the organiser you are responsible for any cleaning and damage restitution costs incurred by the Parliament
- Demonstrators must not impede, interfere with or obstruct access for any Member of Parliament or parliamentary staff whilst travelling to or from the Parliamentary Precinct
- Demonstrators must not block access to the building and a clear path of travel must be available for visitors and guests
- No tents, barriers, signs, flags or other structures, shall be erected on the Parliamentary Precinct or along the footpath bordering the Parliamentary Precinct without prior written approval
- Security Officers will remove and dispose of any structure erected on the Parliamentary Precinct in contravention of these rules.
