1. Purpose

The NT Government has committed to cutting timeframes for regulatory approvals by 50% and tabling legislation in Parliament to remove unnecessary and burdensome regulations.

The NT Government has established the Approvals Fast Track Taskforce (the Taskforce) to provide expert advice on how to achieve this within six months from its commencement.

2. Authority

The Taskforce is a non-statutory advisory group established by the Chief Minister. It holds no delegated powers to act on behalf of the Chief Minister, or to commit the Chief Minister or Government to any actions.

3. Terms of Reference

The Taskforce will provide expert advice to Government on options for decreasing regulatory processing times and easing the burden on business and industry.

This advice should consider:

1. Regulatory policy (including legislation, regulation and policy frameworks); and
2. Regulatory practice (including systems, processes, guidelines, organisational culture and capability, and risk management).

The Taskforce should focus on reforms that will benefit the greatest number of businesses.

The Taskforce is established for six months from the date of the Chair's appointment.

The Taskforce will provide its findings and recommendations to the Chief Minister six months from commencement.

4. Responsibilities

4.1. Chair

The Chair is responsible for leading and directing the activities of the Taskforce. Responsibilities include:

- setting the agenda for Taskforce meetings;
- ensuring the meetings are conducted efficiently and within established protocols;
- managing conflict of interests among members;
- representing the Taskforce to stakeholders and the public;
- liaising with, and reporting to the Chief Minister and the Chief Executive Officer of the Department of the Chief Minister and Cabinet (CM&C) as required;
- reviewing the Taskforce's performance against the Terms of Reference; and
- maintaining ethical standards and fairness and impartiality principles.

4.2. Members

Members of the Taskforce are responsible for contributing expertise and perspective to the activities of the Taskforce. Responsibilities include:

- ensuring minutes are a true and accurate record of the meetings;
- reviewing relevant documents and information presented;
- providing input based on knowledge and expertise on specific issues or initiatives;
- disclosing any conflicts of interest promptly and ensuring any identified contacts are managed, including abstaining from voting on matters where there is a conflict;
- leveraging personal and professional networks to benefit the work of the Taskforce;
- maintaining ethical standards and fairness and impartiality principles; and
- maintaining confidentiality where required and ensuring any commentary in the media or otherwise is directed to the Chair to be dealt with in the appropriate manner.

4.3. Government

CM&C will provide administrative and secretariat support to the Taskforce. The responsibilities of CM&C include:

- taking minutes during meetings;
- coordinating and scheduling meetings and other events as required;
- compiling and maintaining a record of all documentation;
- ensuring that accurate and timely information is provided to the public as required; and
- any other administrative support required, as directed by the Chair.

Relevant government agencies will be required to provide relevant information and data on request to support the deliberations of the Taskforce.

5. Structure and membership

5.1. Membership

The Taskforce will be comprised of up to eight private sector representatives who have direct experience of regulatory approval processes. Membership is determined by direct appointment.

A Chair will be appointed by the Chief Minister.

5.2. Member selection and nomination

Nominations are by Ministerial invitation only.

5.3. Term of appointment

The Chief Minister will appoint members by letter of appointment. The term of appointment for the Taskforce will be six months from the Taskforce's formation or until the final report is delivered, whichever is earlier.

6. Remuneration

Members will not be remunerated for their participation in the Taskforce.

7. Operation

7.1. Meetings

The Chair will determine the regularity of Taskforce meetings in consultation with other members.

Agenda and papers will be circulated to members no less than three days prior to the meeting.

Meetings are to be facilitated by the Chair or, in their absence, a member nominated by the Chair to temporarily act as the Chair.

Whenever possible, decisions of the Taskforce are to be made by consensus. If consensus cannot be reached, decisions will be made by a majority vote of those members present. In the event of a tie, the Chair will have the casting vote. The advice provided to the Chief Minister will outline the diverse range of opinions of members.

7.2. Quorum

A quorum is half the total attending members plus one. A proxy is counted in the quorum and has the authority to vote.

7.3. Proxies

If a member is unable to attend a meeting, with the prior agreement of the Chair they may send a proxy to speak on their behalf.

7.4. Apologies

If a member is unable to attend a meeting, they must submit an apology to the Secretariat. Apologies will be noted in the minutes.

7.5. Briefings to the Chief Executive Officer of CM&C

As soon as practicable after each meeting, the Chair will meet with the Chief Executive Officer of CM&C (or their delegate) to provide an update on the Taskforce's progress.

7.6. Formation of sub-committees

The Taskforce may establish sub-committees to assist it in fulfilling its responsibilities. These sub-committees may be formed for specific purposes, such as the investigation of a specific regulatory process or the delivery of reports.

The Chair will define the scope, composition, and authority of each sub-committee in writing. Sub-committees shall report to the Taskforce and operate within the parameters established by the Taskforce.

8. Confidentiality

Unless otherwise indicated, all papers and minutes are confidential.

The Taskforce will determine what papers are marked for release at the end of each meeting, or in subsequent meetings.

Members may be provided with other confidential material, which should be treated with care and discretion and not be disclosed to anyone outside of the Taskforce.

9. Declaration of interests

A conflict of interest may occur where a member has a financial or other interest in issues under consideration by the Taskforce. Declaring conflicts of interest will be a standing agenda item for each meeting.

A member must disclose to the Chair, any situation or agenda item that may lead to a real, perceived, or potential conflict of interest. The Chair will assess the risk and decide if the member should be excluded from any discussions or situations.

10. Resignation

Members may resign from the Taskforce at any time.

All resignations must be provided in writing to the Chief Minister with a copy provided to the Chair.
